### Taic Freumhan Coimhearsnachd 2019/20 Funding Guidelines

#### Mu dheidhinn na Maoine

Chaidh a' mhaoin Taic Freumhan Coimhearsnachd a stèidheachadh le Bòrd na Gàidhlig gus cothroman a thoirt do bhuidhnean coimhearsnachd pròiseactan a libhrigeadh a tha a' toirt buaidh mhath air cleachdadhbh 's ionnsachadh na Gàidhlig.

#### Mu dheidhinn Bhòrd na Gàidhlig

'S e Buidheann Phoblach Neo-roinneil (BPNR) a th' ann am Bòrd na Gàidhlig a chaidh stèidheachadh fo Achd na Gàidhlig (Alba) 2005. Tha dleastanas reachdail air gus cleachdadhbh na Gàidhlig a chur air adhart agus piseach a thoirt air cor a' chànan air feadh na h-Alba.

Tha e cuideachd an urra ri Bòrd na Gàidhlig a bhith a' toirt thabhartasan seachad às leth Riaghaltas na h-Alba mar thaic do agus gus cur ri cleachdadhbh na Gàidhlig agus bidh e a' toirt comhairle seachad air cùisean co-cheangailte ri cànan is cultar na Gàidhlig.

'S e aon de na dleastanasan a th' air Bòrd na Gàidhlig, a bhith a' cruthachadh [Plana Cànan Nàiseanta Gàidhlig](#) gach còig bliadhna mar ro-innleachd airson leasachadh a' chànan.

Tha gach sgeama maoineachaidh a tha Bòrd na Gàidhlig a' ruith stèidhichte air na prìomhachasan a chithear sa Phlana Nàiseanta sin agus sa [Phlana Chorporra aig a' Bhòrd](#), 's mar sin tha e riatanach gu bheil sibh eòlach orra mus cuir sibh iarrtas maoineachaidh a-steach.

#### About the Fund

The Taic Freumhan Coimhearsnachd fund was created by Bòrd na Gàidhlig to provide opportunities for community groups to deliver projects that promote using and learning Gaelic.

#### About Bòrd na Gàidhlig

Bòrd na Gàidhlig is a Non-Departmental Public Body that was established under the Gaelic Language (Scotland) Act 2005. It has a legislative responsibility for promoting the use and state of the Gaelic language throughout Scotland.

Bòrd na Gàidhlig is also responsible for distributing grant monies from the Scottish Government to support and grow the usage of Gaelic and provide advice on issues relating to the culture and language of Gaelic.

One of the responsibilities of Bòrd na Gàidhlig is to develop a [National Gaelic Language Plan](#) every five years as a strategy for development of the language.

Each funding programme that Bòrd na Gàidhlig manages is based upon the priorities as communicated in this National Plan and the [Bòrd's Corporate Plan](#), and as such it is vital that you are familiar with these documents before you submit a funding application.

## Priorities and Criteria

For Taic Freumhan Coimhearsnachd, projects will be funded that have the largest impact on Gaelic usage, learning or it's public image.

In particular, we are looking for projects that achieve the following specific aims that are identified in [Bòrd na Gàidhlig's Corporate Plan 2018-23](#):

### Increasing the use of Gaelic

- Supporting organisations and individuals to provide more and better activities, events and resources by and for young people
- Encourage more and better opportunities for families to use Gaelic in the home
- Funding initiatives which strengthen language richness, relevance and consistency

### Increasing the learning of Gaelic

- Developing initiatives with partners to increase the impact of early years' support for families
- Encouraging the application of technological advances to deliver more effective and increased adult learning

### Promoting a positive image of Gaelic

- Influencing national and international events and celebrations, such as "The Year

## Riaghailtean airson Phròiseactan

### Clàr-ama a' Phròiseict

Bidh an sgeama a' toirt taic do phròiseactan a thèid a lìbhrigeadh agus a thèid a chrìochnachadh eadar 1 Cèitean 2019 agus 31 Iuchar 2020.

### Ìrean taic-airgid

'S e £105,000 am buidseat gu lèir airson an sgeama seo. Faodar iarrtas a chur a-steach airson suas ri **£5,000** agus suas ri 80% de chosgaisean a' phròiseict. Bu chòir do thagraichean dèanamh cinnteach nach eil pàirt sam bith eile de bhuidseat a' phròiseict a' tighinn bho sgeamaichean maoineachaidh eile aig Bòrd na Gàidhlig.

## Project Requirements

### Project Timeframe

The fund will support projects which will take place and be fully completed between 1 May 2019 and 31 July 2020.

### Funding levels

The total budget allocated to this fund is £105,000. Applications may be made for up to a maximum of **£5,000** and up to 80% of project costs. Applicants must ensure that no other part of the project's budget comes from other Bòrd na Gàidhlig funding schemes.

Applications for Gaelic classes must include income equivalent to **at least £3 per person, per class.**

### Acknowledgment of Funding

For this funding programme, you must acknowledge (where appropriate) that Bòrd na Gàidhlig were the source of funding for your project.

In your application, you must detail how you will achieve this, e.g. acknowledgement in project publicity, use of Bòrd na Gàidhlig's logo on printed materials.

Bidh agaibh ri dà aithisg a chur a-staigh gus an urrainn dhuinn sgrùdadh a dhèanamh air a' phròiseact agaibh. Bidh aithisg adhartais ghoirid a dhìth letheach slighe tron phròiseact, neo sia mìosan a-staigh dhan phròiseact (ge brith cò as giorra).

## Project monitoring and evaluation

Throughout the project, we expect that you will assess your progress regularly and collect information regarding the measures outlined in your contract from the 2018-23 Bòrd na Gàidhlig Corporate Plan.

You will be required to submit two reports relating to the project to allow for monitoring. A short progress report will be due halfway through the project or six months after the start date (whichever is earlier).

At the end of the project, you will be required to submit a final report to confirm what was achieved by the project and to give an outline of how the grant money was spent.

In your final report, we expect that you will give a summary of information collected through the project relating to the measures outlined in the 2018-23 Bòrd na Gàidhlig Corporate Plan.

## Applications

### Who can apply?

Taic Freumhan Coimhearsnachd is specifically designed to be accessible to as wide a range of organisations as possible, in order to encourage and increase the day-to-day use of Gaelic in communities.

Voluntary community organisations, social enterprises, small businesses, sporting, religious, arts and school groups have previously received assistance, but voluntary community organisations will be prioritised.

It is important that any application clearly demonstrates that the project is open to, and for the benefit of the whole community. In the case of schools, only extra-curricular activities will be supported.

Taic Freumhan Coimhearsnachd is not open to applications from individuals or from public bodies.

### Closing date for applications

Applications must be submitted to Bòrd na Gàidhlig no later than **5pm on Friday 22<sup>nd</sup> February 2019.**

Applications that are submitted after this date will not be considered.

Please note, Bòrd na Gàidhlig may request additional information or clarification of project details after the application has been submitted.

### Application review process

All applicants will receive an acknowledgement to confirm that Bòrd na Gàidhlig received their application.

All eligible projects will be assessed in March 2019 by a panel made up of Bòrd na Gàidhlig representatives who will look at the following:

- The project's capacity to achieve the aims in the following areas as identified by the National Gaelic Language Plan and Bòrd na Gàidhlig's Corporate Plan:
  - Increasing Gaelic usage
  - Increasing Gaelic learning
  - Promoting a positive image of Gaelic

## Iarrtasan soirbheachail

Ma thèid gabhail ri iarrtas, thèid litir-tairgse a chur chun an tagraiche. Innsidh sin dè am maoineachadh a thathar a' faighinn (an t-sùim agus an àireamh às a' cheud) agus dè na cumhachan maoineachaидh a th' ann.

Thathar an dùil gun tèid 80% den mhaoineachadh a phàigheadh nuair a thilleas an tagraiche an cùmhant agus nuair a gheibhear dearbhadh air cuin a tha am pròiseact a' tòiseachadh agus am fiosrachadh banca aig an tagraiche. Ma tha sibh air maoineachadh fhaighinn a-cheana, feumaidh sibh aithisgean deireannach a chur thugainn airson nam pròiseactan don d' fhuair sibh taic 's aonta fhaighinn airson nan aithisgean sin mus tèid ur pàigheadh airson an sgeama seo.

Thèid am 20% mu dheireadh a phàigheadh nuair a thèid crìoch a chur air a' phròiseact agus nuair a gheibhear aithisg dheireannach leis a bheil sinn riaraichte, agus fianais air na chaidh a choileanadh. Dh'fhaodadh gun tèid an t-sùim seo a lùghdachadh a rèir dè an teachd-a-steach is dè na cosgaisean a bh' ann aig deireadh a' phròiseict.

Applicants will be informed of the panel's decisions in March 2019.

## Successful applications

If a funding application is successful, a letter of offer will be sent to the applicant. This will explain the level of funding agreed (amount and percentage) and the conditions that apply.

It is expected that 80% of the award will be paid on the return of the contract along with confirmation of the project start date and the applicant's bank details. Please note that if funding has been received in previous years that final reports for those projects must be submitted and approved before we can make any payment for this scheme.

Payment of the final 20% will be at the end of the project and will be conditional on receiving a satisfactory final report, along with evidence of what has been achieved. This payment may be reduced depending on need in terms of final income and expenditure.
