Taic Freumhan Coimhersnachd 2020/21 Funding Guidelines

Mu dheidhinn na Maoine

Mu dheidhinn Bòrd na Gàidhlig

'S e Buidheann Phoblach Neo-roinneil (BPNR) a th' ann am Bòrd na Gàidhlig a chaidh a stèidheachadh fo Achd na Gàidhlig (Alba) 2005. Tha dleastanas reachdail air gus cleachdadadh na Gàidhlig a chur air adhart agus piseach a thoirt air cor a' chànan air feadh na h-Alba.

Tha gach sgeama maoineachaidh a tha Bòrd na Gàidhlig a' ruith stèidhichte air na priomhachasan a chithear sa [Phlana Cànan Nàiseanta Gàidhlig 2018-2023](#) agus sa [Phlana Chorporra aig a' Bhòrd](#), 's mar sin tha e riatanach gu bheil sibh eòlach orra mus cuir sibh iarrtas maoineachaidh a-steach.

Pròiseactan a gheibhear taic

Tha Taic Freumhan Coimhersnachd fosgailte airson iarrtasan bho chomainn agus buidhnean coimhersnachd a tha airson pròiseact a' lìbhrigeadh a bhios a' brosnachadh cleachdadadh na Gàidhlig aig ère ionadail.

About the Fund

Taic Freumhan Coimhersnachd is Bòrd na Gàidhlig's primary fund for supporting opportunities for communities to deliver projects that promote using and learning Gaelic.

Bòrd na Gàidhlig recognises the need to strengthen local communities, particularly for young Gaelic speakers, and are looking to support this through this fund.

About Bòrd na Gàidhlig

Bòrd na Gàidhlig is a Non-Departmental Public Body that was established under the Gaelic Language (Scotland) Act 2005. It has a legislative responsibility for promoting the use and state of the Gaelic language throughout Scotland.

Each Bòrd na Gàidhlig funding programme is based upon the priorities as communicated in the current [National Gaelic Language Plan 2018-2023](#) and the [Bòrd's Corporate Plan](#), and as such it is vital that you are familiar with these documents before you submit your application.

Projects this fund aims to support

Taic Freumhan Coimhersnachd is open to applications from organisations and community groups that are looking to deliver a project that will encourage the usage of Gaelic on a local level.

- A' toirt fàs air cleachdadhe na Gàidhlig;
- A' toirt fàs air ionnsachadh na Gàidhlig; agus
- A' cur deagh ìomhaigh air adhart airson na Gàidhlig

Tha sinn cuideachd airson gu bheil iarrtasan a' toirt fa-near mar as urrainn dha na phròiseactan aca a' cur ri comharrachaidhean agus tachartasan ionadail, nàiseanta is eadar-nàiseanta eile, leithid [Bliadhna Cladaichean agus Uisgeachan na h-Alba 2020](#) agus Bliadhna Cholmcille 2021.

Mu dheireadh, tha sinn airson gum bi gach iarrtas a' mìneachadh na dileib a tha iad faicinn leis a' phròiseact a thaobh cleachdadhe na Gàidhlig sa choimhairsnachd.

Ann a bhith a' measadh an iarrtais agaibh, bidh sinn a' coimhead air:

- Inbhe a' phròiseict agus an tagraiche fhèin
- Na buannachdan a thig às a' phròiseact dhan choimhairsnachd Ghàidhlig ionadail

This year's scheme would specifically like to support projects that achieve the following:

- Promoting extra-curricular Gaelic usage for Gaelic-medium education pupils
- Promoting the usage of Gaelic in the home
- Supporting projects and events to encourage Gaelic use in the community
- Supporting opportunities for adults to use and learn Gaelic
- Promoting the accessibility and awareness of Gaelic heritage in communities across Scotland

In your application we expect you to expand on how your project meets one or more of these aims, as well as the core aims that are identified in the [National Gaelic Language Plan 2018-23](#):

- Increasing Gaelic usage;
- Increasing the learning of Gaelic; and
- Promoting a positive image of Gaelic

We're also looking for applications to consider how their projects can contribute to other local, national and international celebrations and events, for example [Scotland's Year of Coasts and Waters 2020](#) and the Year of Colmcille 2021.

Finally, we'd like all applications to explain the legacy that they see the project having in terms of Gaelic use in the community.

In assessing your application, we will be looking at:

- The quality of the project and the applicant
- The benefits of the project for the local Gaelic community

Co dh' fhaodas tagradh a chur a-steach?

Tha a' mhaoin seo fosgailte do bhuidhnean a tha stèidhichte ann an Alba, no ag obair ann an Alba, aig a bheil bun-reachd agus a tha airson pròiseact ionadail a libhrigeadh gus cleachdadha na Gàidhlig a bhrosnachadh.

Tha iomairtean sòisealta, buidhnean spòrs, creideimh, sgoiltean, agus buidhnean ealain air taic fhaighinn roimhe, ach tha prìomhachas air buidhnean coimhleachd saor-thoileach.

Project Requirements

Who can apply?

This fund is open to constituted organisations based in Scotland, or working in Scotland, that hope to deliver a local project to promote the use of Gaelic.

Social enterprises, sporting, religious, schools and arts groups have previously received assistance, but voluntary community organisations will be prioritised.

Organisations may submit multiple applications for different projects. However, Bòrd na Gàidhlig will aim to support as wide a range of organisations across Scotland as possible.

Who cannot apply?

- Individuals
- Public or local authorities
- Commercial or for-profit organisations
- Bòrd na Gàidhlig Delivery Partners

Project Timeframe

The fund will support projects which will start between 1 April 2020 and 31 March 2021 and will be fully completed by 31 August 2021.

Funding levels

The estimated budget allocated to this fund is £125,000. Applications may be made for up to a maximum of **£5,000** and **up to 80% of project costs**.

You must ensure that no other part of the project's budget comes from other Bòrd na Gàidhlig funding schemes or regular funding programmes.

Applications for Gaelic classes must include income of an equivalent of £3 per person per class.

We will not be able to support project costs relating to:

- Running costs of organisations
- Organisation start-up costs
- Overnight accommodation costs
- Costs relating to attending the Royal National Mòd
- Equipment costs
- Competitions
- Delivering part of the school curriculum

Successful applications will typically receive 80% of the total grant at the start of the project, with the final 20% pending submission of a satisfactory final report.

Acknowledgment

For this funding programme, you must acknowledge (where appropriate) that Bòrd na Gàidhlig were a source of funding for your project as part of your publicity efforts.

In your application, you must detail how you will achieve this, e.g. acknowledgement in project publicity, use of Bòrd na Gàidhlig's logo on printed materials.

Applications must be submitted to Bòrd na Gàidhlig no later than **3pm on Tuesday 21 January 2020.**

Applications that are submitted after this date will not be considered except if prior permission has been provided in writing by Bòrd na Gàidhlig officers.

It is essential that your organisation has an active UK bank account at the time of applying.

Please note, Bòrd na Gàidhlig may request additional information or clarification of project details after the application has been submitted.

Application review process

All applicants will receive an acknowledgment to confirm that Bòrd na Gàidhlig have received their application.

Bòrd na Gàidhlig officers will then screen applications to ensure they comply with the rules of the fund and have provided necessary information. If your application is deemed ineligible, you will be asked to rectify this within 10 working days or your application will be declined.

Taic Freumhan Coimhersnachd 2020/21 Assessment Guidance

Sgrùdadadh ro-mheasaidh air iarrtasan / Pre-assessment application screening

Bu chòir gun tèid gach iarrtas a sgrùdadadh mus tèid e airson measadh gus dearbhadh gu bheil e a' leantainn riaghailtean an sgeama. Mur eil e a' leantainn nan riaghailtean a leanas, bu chòir gun tèid iarraidh air an neach-iarrtais na mearachdan a cheartachadh taobh a-staigh 10 làithean-obrach, no cha tèid an t-iarrtas air adhart airson measadh, agus thèid an t-iarrtas a dhiùltadh.

Each application should be screened before assessment to ensure it follows the rules of the scheme. If it does not follow the rules below, the applicant should be asked to correct any errors within 10 working days, or the application will not be assessed, and the application declined.

Molaidean airson sgòradh / Scoring recommendations

Tha an stiùireadh seo ann gus cuideachadh le bhith measadh iarrtasan airson Taic Freumhan Coimhersnachd 2020/21. Tha dà phàirt den stiùireadh: Buaidh a' Phròiseict agus Libhrigeadh a' Phròiseict. Thathar an dùil gum bi sgòr de 60% no nas àirde gu h-ionlan agus co-dhiù 1 airson gach slat-tomhais a dhìth airson iarrtas a bhith soirbheachail.

This guidance provides support in assessing applications for Taic Freumhan Coimhersnachd 2020/21. There are two parts to the assessment: Project Impact and Project Delivery. It is expected that a score of 60% or more overall and of at least 1 for each measure is required for an application to be successful.
