Appendix – Gaelic Early Years Grants 2022/23 Assessment Guidance

Sgrùdadh ro-mheasaidh air iarrtas / Pre-assessment application screening

Bu chòir gun tèid gach iarrtas a’ sgrùdadh mus tèid e airson a’ mheasadh airson dearbhadh gu bheil e leantainn riaghailtean na sgeama. Mur eil e leantainn na riaghailtean a leanas, bu chòir gun tèid iarraidh air an neach-iarrtais na mearachdan ceartachadh taobh a-staigh 10 làithean-obrach, no nach tèid an iarrtas air airson ri measadh, agus thèid an iarrtas a dhiùltadh.

Each application should be screened before assessment to ensure it follows the rules of the scheme. If it does not follow the rules below, the applicant should be asked to correct any errors within 10 working days, or the application will not be assessed, and the application declined.

- Iarrtas taic-airgid fo £5,000 (ma tha iad libhrigeadh 1 seisean san t-seachdain) no fo £15,000 (airson 2+ seiseanan san t-seachdain)
- Iarrtas taic-airgid aig no nas lugha na 80% de chosgaisean iomlan a’ phròiseict
- Teachd-a-steach agus cosgaisean slàn airson a’ bhuidheann ri fhaighinn
- Fiosrachadh-taice riatanach air a chur a-steach
- Ainmean air a chur ris an iarrtas le ball den Chomataidh
- Funding request of £5,000 or under (if delivering 1 session per week) or £15,000 or under (for 2+ sessions per week)
- Funding request at or under 80% of total project costs
- Full projected income and expenditure outlined
- Required supporting documentation submitted
- Application signed by committee member

Molaidhean airson sgòradh / Scoring recommendations

Tha an stiùireadh seo ann gus taic a thoirt do mheasadh iarrtas airson Tabhartasan nan Tràth-bhliadhnaichean 2022/23. Tha dà phàirt den stiùireadh: Buaidh a’ Bhuidhinn agus Libhrigeadh a’ Bhuidhinn. Thathar an dùil gum bi sgòr de 60% no nas àirde gu h-iomlan agus co-dhiù 1 airson gach slat-tomhais a dhìth airson iarrtas a bhith soirbheachail.

This guidance provides support to assessing applications for the Gaelic Early Years Grants 2022/23. There are two parts to the assessment: Impact of the Group and Delivery of the Group. It is expected that a score of 60% or more overall and of at least 1 for each measure is required for an application to be successful.

Bu chòir gach puing-measaidh air a bhith a’ sgòradh a-mach a 5, le stiùireadh gu h-ìosal air na tha gach sgòr a’ comharrachadh. Ma tha stiùireadh sònraichte ann airson puing-measaidh, bu chòir sin a bhith air an gabhail mar prìomhachais.

Each assessment criteria should be scored out of 5, with guidance below on what each score represents. However, if there is specialist guidance provided then that should be considered as a priority.

Tabhann taic-airgid / Funding offers

Airson gach iartras a tha am pannal-measaidh a' moladh, bidh iad a' moladh suim airson a thabhann a dh'ionnsaigh chosgaisean bunaiteach (tuarastalan, màl agus cosgaisean eile an àite), agus cosgaisean eile. Faodaidh iad moladh suim taic-airgid a thabhann a tha nas lugha na an t-suim a chaidh iarraidh.

For each application that the assessment panel recommends, they shall recommend a sum to award towards basic costs (wages, rent & other venue costs) and other costs. The panel may recommend a funding offer that is lower than the requested sum.

Às dèidh measadh a dhèanamh air a h-uile iartras, ma tha am pannal-measaidh a' moladh cus iarrtasan airson buidseat na maoinne, thèid lùghdachadh air na molaidhean taic-airgid gus am bi an ìre taic-airgid slàn a th' air a moladh taobh a-staigh a' bhuidseit. Ann a bhith a' dèanamh seo, bu chòir prìomhachas a thoirt do chosgaisean bunaiteach (tuarastail airson stiùirichean-cluiche le Gàidhlig, màl agus cosgaisean eile an àite) do gach buidheann a fhuair sgòr iomchaidh.

After assessment of all applications, if the assessment panel recommends more applications than the fund budget can allow, the funding recommendations will be reduced by a level to bring the total recommended support within budget. In doing so, priority should be given to supporting basic costs (wages of Gaelic-speaking playleaders, rent and other venue costs) for all groups that receive an appropriate score.
