Gaelic Early Years Grants 2022/23 Funding Guidelines

Mu dheidhinn na Maoine

Tha sgeama Tabhartasan nan Tràth-bhliadhnaichean Gàidhlig ri fhaighinn airson taic a thoirt do bhuidhnean tràth-bhliadhnaichean Gàidhlig gus seiseanan tro mheadhan na Gàidhlig a ruith do chlann aig aois 0-3. Tha an sgeama a' cur taic ri amasan a' Phlana Cànain Nàiseanta Ghàidhlig ri linn cleachdadh na Gàidhlig aig an taigh agus foghlam nan tràth-bhliadhnaichean.

Tha a' mhaoin air a ruith ann an com-pàirt eadar Bhòrd na Gàidhlig is Comann nam Pàrant is ann air sgàth taic Riaghaltas na h-Alba tro thabhartas MTCOT is IICC (Mhaoin airson Tràth-thaic do Chloinn, Òigridh is Teaghlaichean agus Ionnsachadh do dh'Inbhich is Cumhachd do Choimhearsnachdan) a fhuaras tro Chomann nam Pàrant.

Mu dheidhinn Bòrd na Gàidhlig

'S e Buidheann Phoblach Neo-roinneil (BPNR) a th' ann am Bòrd na Gàidhlig a chaidh a stèidheachadh fo Achd na Gàidhlig (Alba) 2005. Tha dleastanas reachdail air gus cleachdadh na Gàidhlig a chur air adhart agus piseach a thoirt air cor a' chàin air feadh na h-Alba.

Mu dheidhinn Comann nam Pàrant

'S e buidheann nàiseanta a th' ann an Comann nam Pàrant a bhios ag obair às leth phàrantan aig a bheil clann ann am foghlam tron Ghàidhlig. Tha a' bhuidheann ann gus dèanamh cinnteach gum bi cothroman ann air foghlam tron Ghàidhlig agus gun tèid foghlam tron Ghàidhlig a chumail suas air feadh Alba, agus bidh iad ag obair gu dlùth còmhla ri buidhnean phàrant ionadail.

Cò dhà a tha an sgeama seo?

Tha sgeama Tabhartasan nan Tràth-bhliadhnaichean Gàidhlig ri fhaighinn do na buidhnean tràth-bhliadhnaichean uile a tha airson seiseanan tro mheadhan na Gàidhlig a libhrigeadh airson clann aig aois 0-3 anns a' bhliadhna-sgoile 2022/23.

About the Fund

The Gaelic Early Years Grants scheme is available to support Gaelic early years groups to provide sessions through the medium of Gaelic to children aged 0-3, supporting the objectives of the National Gaelic Language Plan with regard to use of Gaelic in the home and early years education.

The fund is run in partnership by Bòrd na Gàidhlig & Comann nam Pàrant and made possible by the support of the Scottish Government through a CYPFEIF and ALEC (Children, Young People and Families Early Intervention & Adult Learning and Empowering Communities) Fund Grant as received from Comann nam Pàrant.

About Bòrd na Gàidhlig

Bòrd na Gàidhlig is a Non-Departmental Public Body that was established under the Gaelic Language (Scotland) Act 2005. It has a legislative responsibility for promoting the use and state of the Gaelic language throughout Scotland.

About Comann nam Pàrant

Comann nam Pàrant (Nàiseanta) is a national organisation working on behalf of parents of pupils in Gaelic-medium education. It aims to ensure the availability and maintenance of Gaelic-medium education throughout Scotland, working closely with local parents' organisations.

Who is this scheme for?

The Gaelic Early Years Grants are available to all early years groups that are looking to deliver sessions for children aged 0-3 through the medium of Gaelic in the 2022/23 school year.

Bheir an sgeama prìomhachas do bhuidhnean aig a bheil ìre charthannais. Thathar an dùil gum bi inbhe charthannais riatanach gus taic fhaighinn tron sgeama seo san àm ri teachd, mar sin thathar a' moladh gun obraich buidhnean saor-thoileach a dh'ionnsaigh inbhe charthannais tro bhliadhna 2022/23.

Tha sgeama am bliadhna gu sònraichte ag amas air taic a chur ri bhuidhnean a tha sealltainn mar a bhios iad a' coileanadh na leanas:

- A' daingneachadh gu bheil cothrom seasmhach aig clann is teaghlaichean air solar tràth-bhliadhnaichean Gàidhlig
- A' cur ris an àireamh chloinne a tha a' cumail a' dol le ionnsachadh tron Ghàidhlig aig ìrean eadar-ghluasaid
- A' cuideachadh barrachd theaghlaichean ann an Alba a bhith mothachail air na buannachdan a thig bho dhà-chànanas agus air na cothroman a gheibhear le foghlam tron Ghàidhlig
- A' cuideachadh phàrantan gus am bi eòlas nas fheàrr aca air goireasan agus air na cothroman a th' ann gus taic a chumail is conaltradh a dhèanamh ri an cuid chloinne tron Ghàidhlig san taigh agus sa choimhearsnachd

Anns an iarrtas agaibh bhitheamaid an dùil gum bi sibh a' mìneachadh ciamar a bhios am buidheann agaibh a' freagairt orra seo, agus air na h-amasan den [Phlana Cànan Nàiseanta Gàidhlig 2018-23](#):

- A' toirt fàs air cleachdadh na Gàidhlig;
- A' toirt fàs air ionnsachadh na Gàidhlig; agus
- A' cur deagh ìomhaigh air adhart airson na Gàidhlig

Ann a bhith a' measadh an iarrtais agaibh, bidh sinn a' coimhead air:

- Cho math agus a tha a' bhuidheann a' freagairt air prìomhachasan na maoin
- Comasan na buidhne gus seiseanan Gàidhlig aig deagh inbhe a libhrigeadh
- Cho math agus a tha a' bhuidheann a' cumail taic ri cleachdadh, ionnsachadh is cur air adhart na Gàidhlig sa choimhearsnachd
- Soirbheachas na buidhne ann a bhith a' cur ri àireamhan frithealaidh, àireamhan a' dol air adhart gu FtG agus ann a bhith a' cur air adhart na Gàidhlig san sgìre
- Comasan na buidhne gus sùil a chumail air is measadh a dhèanamh air adhartas
- Luach an airgid ga shealltainn anns an iarrtas

The scheme will prioritise support to groups that have charitable status. Future versions of this scheme are likely to require that groups supported have charitable status, and voluntary groups are recommended to work towards attaining charitable status in the course of 2022/23.

This year's scheme would specifically like to support groups that can show how they will achieve the following:

- Ensuring that children and families have sustained access to Gaelic early years provision
- Increasing the number of children continuing with Gaelic-medium learning at key transition stages
- Helping more families in Scotland become aware of the benefits of bilingualism and the opportunities offered by Gaelic-medium education
- Helping parents become better informed on resources and opportunities to support and interact with their children through Gaelic in homes and communities

In your application we expect you to expand on how your group meets these aims, as well as the core aims that are identified in the [National Gaelic Language Plan 2018-23](#):

- Increasing Gaelic usage;
- Increasing the learning of Gaelic; and
- Promoting a positive image of Gaelic

In assessing your application, we will be looking at:

- How well the group meets the aims of the fund
- The ability of the group to deliver high-quality Gaelic early years sessions
- How well the group supports the wider usage, learning and promotion of Gaelic in the community
- The success of the group in growing attendee numbers, numbers progressing to GME and promoting Gaelic in its area
- The ability of the group to monitor and assess its progress
- The value for money demonstrated by the application

Riaghailtean

Clàr-ama

Bheir a' mhaoin taic do sheiseanan na buidhne a thèid a libhrigeadh eadar 1 Lùnastal 2022 agus 10 Iuchar 2023. Dh' fhaodadh taic a thoirt seachad taobh a-muigh an clàr-ama seo ma cheadaicheas Bòrd na Gàidhlig is Comann nam Pàrant ann an suidheachadh air leth.

Ìrean taic-airgid

'S e £120,000 am buidseat ris a bheilear an dùil airson an sgeama seo.

Faodaidh buidhnean a tha libhrigeadh 1 seisean san t-seachdain a-mhàin suas ri **£5,000** a shireadh, ach faodaidh buidhnean a tha a' libhrigeadh barrachd na 1 seisean san t-seachdain suas ri **£15,000** a shireadh.

Thathar an dùil gum bi gach buidheann a' togail airgid bho thùsan eile (m.e. taic-airgid eile no cìsean frithealaidh) agus gum bi tabhartasan bhon mhaoin seo a' cur taic suas ri 80% de chosgaisean slàna na buidhne aig a' char as fhaide.

Bu chòir do thagraichean dèanamh cinnteach nach eil pàirt sam bith eile de bhuidseat a' phròiseict a' tighinn bho sgeamaichean maoin eachaidh eile aig Bòrd na Gàidhlig.

Cuiridh a' mhaoin prìomhachas air taic a chumail ri tuarastalan stiùirichean-cluiche aig a bheil Gàidhlig, màl nan seòmraichean agus cosgaisean eile an àite ma tha iarrrtas nas àirde airson maoin na tha ann sa bhuidseat.

Bu chòir stiùirichean-cluiche a tha a' faighinn taic tron sgeama seo a bhith fileanta sa Ghàidhlig, agus tha sinn a' moladh gum bi buidhnean a' pàigheadh aig [ìre an Tuarastal Bith-beò Albannaich \(£9.90 san uair\)](#).

Chan fhaod an taic-airgid againn a bhith air a cosg air cuairtean, pàrtaidhean no tiodhlacan.

Feumaidh gach buidheann a gheibh taic a bhith a' leantainn lagh is stiùireadh bho Riaghaltas ma h-Alba a thaobh sgaoilidhean a' choròna-bhìorais fad na h-ùine, agus bu chòir iarrrtasan cuideachd a bhith mothachail air cuingealachaidhean a dh'fhaodadh a bhith ann ri linn sgaoilidhean a' choròna-bhìorais agus a' cur an cèill mar a bhios am buidheann a' dèiligeadh ri seo.

Requirements

Timeframe

The fund will support group sessions which will take place and be fully completed between 1 August 2022 and 10 July 2023. Support outwith this timeframe may be provided in exceptional circumstances at the discretion of Bòrd na Gàidhlig and Comann nam Pàrant.

Funding levels

The estimated budget allocated to this fund is £120,000.

Groups that deliver only 1 session per week can apply for a maximum of **£5,000**, while groups that deliver more than 1 session per week can apply for a maximum of **£15,000**.

It is expected that each group will raise money from other sources (i.e. other funding or attendance fees) and that grants from this fund will be up to a maximum of 80% of total group costs.

Applicants must ensure that no other part of the project's budget comes from other Bòrd na Gàidhlig funding schemes.

The fund will prioritise supporting costs for wages of Gaelic-speaking playleaders, venue rent and venue costs in the event that the fund is oversubscribed.

All playleaders supported through this fund should be fluent Gaelic-speakers, and we encourage all groups to pay [a minimum of the Scottish Living Wage \(£9.90 per hour\)](#).

Our funding cannot be used towards the costs of trips, parties or gifts.

All groups that receive support must comply at all times with laws and guidance from the Scottish Government relating to coronavirus outbreaks, and applications should consider restrictions that may be in place due to coronavirus outbreaks and explain how the group's work will deal with such scenarios.

- “Attending the group has enhanced my child's Gaelic skills.”
- “Having my child attend the group has made me believe more strongly that Gaelic is important to Scotland”

Evidence should be provided in your application as to how you will collect this feedback.

Application review process

All applicants will receive an acknowledgment to confirm that Bòrd na Gàidhlig have received their application. If you do not receive acknowledgment within two working days please contact Bòrd na Gàidhlig to ensure the application has been received.

Bòrd na Gàidhlig officers will then screen applications to ensure they comply with the rules of the fund and have provided necessary information. If your application is deemed ineligible, you will be asked to rectify this within 10 working days or your application will be declined without assessment.

All eligible applications will be assessed by a panel of Bòrd na Gàidhlig and Comann nam Pàrant officers according to the assessment guidance, and they will recommend to Bòrd na Gàidhlig's Senior Management Team which applications to approve at their meeting in mid-August 2022.

All applicants will be informed of the result of their application in mid-to-late August 2022.
