Risk Management

NP gave an overview of the Strategic Risk Register. The Register showed all proposed amendments made since the last committee meeting and NP provided information on these. It was noted that once these changes are applied, this will give a clear and focussed register of the strategic risks BnG is facing,

NP clarified to members why some risk ratings may have changed. There was some discussion around how risk ratings should be presented.

KW confirmed that this Register is a similar style to those used in other organisations.

Action:

It was requested that more detail be added to some descriptions and more of a distinction made between the description and consequence at 3.1 and 4.3.

It was also suggested that using the current unmitigated risk rating would be more useful than the initial/ mitigated risk register ratings.

Decision:

Members approved the Risk Management Register subject to any changes raised.
