**Update Report – Teacher Recruitment and Retention**

SW provided information on steps being taken by Bòrd na Gàidhlig to support teacher recruitment and retention, for example school visits and conferences and events for probation teachers.

SW provided information on the consultation on examinations and qualifications, an event as part of the National Discussion on education at the Scottish Learning Festival and discussions with Comunn nam Pàrant Nàiseanta and the Government.

He gave an overview on education in Inverclyde and how the work here will affect Gaelic-medium secondary school education nationally.

**New Teacher and Teaching Student Figures**

JW thanked Members for agreeing to open the immersion funding scheme for this year and reported on the impact of this.

The importance of teaching courses in Edinburgh University for Gaelic, and opportunities for developments in various parts of the country, were raised. Information

Mar thoradh air buaidhean a' ghalair lèir-sgaoilte tha oilthighean a' gluasad gu modalan libhrigidh measgaichte, a tha a' nochdadh chothroman a bharrachd air dùbhlain.

Dh'fhaighnich Buill cuideachd ciamar as urrainnear tidsearan a tha ag obair tro mheadhan na Beurla le sgilean Gàidhlig a bhrosnachadh gus a bhith ag obair tro mheadhan na Gàidhlig. Thug SW fios mu dhiofar dhòighean san urrainnear seo a dhèanamh agus cuideachd mu na bacaidhean a dh'fhaodadh a bhith mu choinneamh seo.

was provided on the number of people who have taken a range of courses to teach through the medium of Gaelic.

Members asked if online affairs has affected the training of new teachers. JW informed the committee that the numbers of student teachers have remained relatively stable with 73 at different levels of ITE training in the session 21-22 and 68 in the session 22-23. Numbers of teachers being placed on immersion courses with Bòrd support remained low but stable (2 or 3 each year since the start of the pandemic). A feature of the impact of the pandemic has been universities moving to hybrid models of delivery, which presents some opportunities as well as challenges.

Members also asked how teachers who work through the medium of English who have Gaelic skills could be encouraged to work through the medium of Gaelic. JW provided information about different ways this could be done and also what the obstacles could be.
