INTERNAL AUDIT REPORTS

Internal Audit: Quarterly ReportsGrants to Gaelic Organisations

SMC informed Members that this review is undertaken annually to ensure that the grants are processed appropriately and that this received a strong level of assurance. Some more information was provided on how this conclusion was reached and that they were very happy with the process.

It was confirmed for Members that the reports are financial-based reports and do not refer to the outputs of the projects that receive funding.

Budgetary and Financial Reporting

SMC told Members that this was another strong report and explained the layout of the report and some of the research done to produce these results. He gave an overview of their findings and that these were positive overall.

NP confirmed that the desk notes to supplement the Scottish Public Finance Manual will be reviewed before the end of the calendar year.

Members asked if there were any learning opportunities to be taken from areas of good practice which Wylie Bisset identifies in other organisations. SMC confirmed that officers from Wylie Bisset pass on any appropriate best practice during their regular discussions with BnG officers.

AUDIT RECOMMENDATIONS

Status of Audit Recommendations

NP gave an overview of the paper. As requested at the last meeting a column was added to the report which shows when each recommendation was raised. Progress was made across all of the outstanding actions since the last committee meeting.

NP informed members that the first recommendation was partially complete and, along with the second recommendation will be completed once the cloud based finance system is fully implemented, hopefully by end of calendar year. The third recommendation was being finalised and should be completed by the end of this month, and the fourth recommendation has now been completed.

Members asked about recommendations relating to training. NP informed members that there is training on procurement available and that this will be updated when the cloud-based finance system is fully implemented if necessary.

Members noted that some completion dates on the register had passed, and NP gave updates on these points and that these actions were all proposed improvements to systems currently in place that give assurance over processes and procedures.

Decision:

Members approved the paper.

RISK MANAGEMENT

Risk Management

NP informed Members that the Risk Register showed all the proposed amendments made since the last committee meeting. She provided an overview of those risks which had their ratings changed.

As requested at the last meeting the initial risk rating pre and post mitigation were removed, and the register now included an estimation of the current risk rating if no mitigation measures were in place.

Members confirmed that the risk ratings reflected the risk while mitigations were in place.

Members noted some presentation issues with the register and NP assured Members that this will be resolved going forward.

Members discussed the risk around the reputation of the organisation and the Ceannard provided some ways in which the organisation is acting on this and ways they would like to, for example the addition of a Public Affairs and Policy Officer which is a part of the business case.
