

Stiùireadh Maoin Phlanaichean Gàidhlig 2023/24 Gaelic Plans Fund 2023/24 Funding Guidelines

Mu dheidhinn na Maoine

Tha Maoin Phlanaichean Gàidhlig (a b' àbhaist a bhith air ainmeachadh GLAIF) airson ùghdarrasan poblach a chuideachadh gus na Planaichean Gàidhlig aca a chur an gnìomh agus taic a chur ris a' Phlana Càinain Nàiseanta Ghàidhlig. Tha ùghdarrasan poblach cuideachd air taic-airgid fhaighinn tro Maoin Phlanaichean Gàidhlig gus pròiseactan a thoirt gu buil mus tèid iarraidh orra gu foirmeil Plana Gàidhlig a sgrìobhadh.

Tha sgeama na bliadhna seo gu sònraichte ag amas air taic a chur ri buidhnean a bhios a' libhrigeadh phròiseactan a tha a' coileanadh na leanas:

- A' brosnachadh cleachdad na Gàidhlig is a' togail comasan airson leasachadh na Gàidhlig anns a' choimhleachd, gu h-àraidh am measg dhaoine òga
- A' cur ri inbhe, cunbalachd is faotainneachd na Gàidhlig tro sheirbheisean coitcheann agus conaltradh an ùghdarrais
- A' neartachadh chomasan Gàidhlig, a' cur ri mothachadh Gàidhlig agus a' cruthachadh barrachd cothroman gus Gàidhlig a chleachdad am measg ùghdarrasan poblach agus an luchd-obrach aca
- A' brosnachadh leasachadh agus leudachadh foghlam Gàidhlig (FtG agus FLi) agus ionnsachadh na Gàidhlig do dh'inhich
- A' toirt cothroman do dhaoine òga Gàidhlig a chleachdad san àite-obrach is sgilean-obrach a thogail

- A' toirt fàs air cleachdad na Gàidhlig
- A' toirt fàs air ionnsachadh na Gàidhlig
- A' cur deagh iomhaigh air adhart airson na Gàidhlig

About the Fund

The Gaelic Plans Fund (formerly named GLAIF) is available to help public authorities in the delivery of commitments in their Gaelic Language Plans, and in support of the National Gaelic Language Plan. The Gaelic Plans Fund has also been used to assist other public authorities in the delivery of projects ahead of their formal notice to produce a Gaelic Language Plan.

This year's scheme would specifically aim to support organisations to deliver projects that achieve the following:

- Promoting Gaelic usage and building capacity for Gaelic development in the community, especially among young people
- Promoting the status, consistency and availability of Gaelic through the general services and communications of the authority
- Strengthening Gaelic skills, promoting awareness of Gaelic and creating more opportunities to use Gaelic among public authorities and their staff
- Promoting the development and expansion of Gaelic education (GME and GLE) and adult learning of Gaelic
- Providing opportunities for young people to use Gaelic in the workplace and to develop work skills

In your application we expect you to expand on how your project meets one or more of these aims, as well as how it supports the actions of [Bòrd na Gàidhlig's Corporate Plan 2018-23](#) and the core aims that are identified in the [National Gaelic Language Plan 2018-23](#):

- Increasing Gaelic usage
- Increasing the learning of Gaelic
- Promoting a positive image of Gaelic

- Cho math 's a bhios am pròiseact a' cur ri buileachadh planaichean Gàidhlig
- An iùre de dh'ùr-ghnàthachas is obair com-pàirteachais air an cur an cèill san iarrtas
- Comas am buidheann agaibh am pròiseact lìbhrigeadh gu soirbheachail
- Neart nam planaichean agaibh gus buaidh a' phròiseict agaibh a mheasadh
- Luach an airgid a tha ga shealltainn leis a' phròiseict

Riaghailtean airson Phròiseactan

Cò dh'fhaodas tagradh a chur a-steach?

Tha a' mhaoin seo fosgailte do dh'ùghdarrasan poblach/ionadail Albannach uile, ach le prìomhachas air an fheadhainn a tha a' buileachadh Plana Gàidhlig reachdail, ag ullachadh Plana Gàidhlig reachdail, no a th' air fios fhaighinn bho Bhòrd na Gàidhlig gun tèid iarraidh orra Plana Gàidhlig reachdail ullachadh.

Faodaidh buidhnean leth-eisimeileach aig ùghdarrasan ionadail iarrtas a chur a-steach, ach bithear an dùil gum bi iad a' sealltainn mar a bhios am pròiseact aca a' cur ri lìbhrigeadh Plana Gàidhlig an ùghdarrais/nan ùghdarrasan poblach leis a bheil iad. Gheibhear eisimpleirean de phròiseactan a fhuair taic bhon sgeama seo a-cheana (mar GLAIF) [tron làrach-lìn GrantNav](#).

Tha fàilte air iarrtasan bho bhuidhnean ag obair còmhla, ach bu chòir na h-iarrtasan seo prìomh bhuidheann ainmeachadh airson a' chùmhaint taic-airgid.

Faodaidh buidhnean suas ri 5 iarrtasan a chur a-steach don chuairt maoineachaидh am-bliadhna, ach bidh am Bòrd ag amas air taic a chumail ri caochladh bhuidhnean poblach air

The fund also seeks to support new and strategic projects to help advance a *Faster Rate of Progress* in delivering the [National Gaelic Language Plan 2018-2023](#), particularly by promoting co-operation between public authorities and between public authorities and community-based organisations.

In assessing your application, we will be primarily looking at:

- The quality of the project and the applicant
- How clearly the project demonstrates a connection with the fund's priorities
- How clearly the project will benefit the implementation of Gaelic language plans
- The level of innovation and partnership working shown in the application
- The ability of your organisation to deliver the project successfully
- The strength of your plans to assess the impact of your project
- The value for money demonstrated by the project

Project Requirements

Who can apply?

This fund is open to all Scottish public/local authorities, with priority given to those that are implementing a statutory Gaelic Language Plan, preparing a statutory Gaelic Language Plan or have been notified by Bòrd na Gàidhlig that they will be asked to prepare a statutory Gaelic Language Plan.

Arms-length organisations (ALEOs) of local authorities may apply but will be expected to demonstrate how their project will implement the Gaelic Language Plan of their parent public authority/authorities. Examples of projects that have previously received support through this fund (as GLAIF) [can be found via the GrantNav website](#).

Joint applications between organisations are welcomed, although such applications should identify a lead organisation for contractual purposes.

Organisations may submit up to a maximum of 5 applications to this year's funding round. However, Bòrd na Gàidhlig will aim to support as wide a range of bodies across

Clàr-ama a' Phròiseict

Bidh an sgeama a' toirt taic do phròiseactan thòisicheas eadar 1 Lùnastal 2023 agus 31 Màrt 2024 agus a thèid criochnachadh ro 31 Lùnastal 2024.

Ann an suidheachaidhean sònraichte, faodaidh iarrtas clàr-ama eadar-dhealaichte a mholadh. Feumaidh conaltradh a bhith ann air seo le oifigearan a' Bhùird agus cead a bhith air a thoirt seachad mus tèid an t-iarrtas a chur a-steach, le fianais air a' chead seo air a thoirt seachad an cois an iarrtais.

Dè na cosgaisean a gheibh taic?

'S e £440,000 am buidseat ris a bheilear an dùil airson an sgeama seo. Faodar iarrtasan airson pròiseactan a chur a-steach airson suas ri **£25,000 agus suas ri 80% de chosgaisean a' phròiseict**. Tha cosgaisean neo-ionmhasail ceadaichte mar phàirt de chosgaisean iomlan a' phròiseict.

Ann an suidheachaidhean sònraichte, dh'fhaodadh gum faigh pròiseactan barrachd air an ère taice as àirde far a bheil dearbhadh ann gum faodadh buaidh ro-innleachdail no fad-ùine a bhith aig seo. Feumaidh sibh cead fhaighinn bho oifigearan Bòrd na Gàidhlig gus barrachd air £25,000 a shireadh, le fianais air a' chead seo air a thoirt seachad an cois an iarrtais.

Bhithean an dùil gum bi pròiseactan a bha air taic fhaighinn tro GhLAIF a-cheana a' sealltainn adhartas ann an luach an airgid agus àbhaisteachadh na Gàidhlig ann an obair na buidhne thairis air iarrtasan a bh' ann a-cheana.

Scotland as possible. As such, any element that is required for the delivery of multiple projects (e.g. staff time) must be included proportionally in each application, whilst ensuring that there is no duplicate funding requested.

Who cannot apply?

- Individuals
- Community groups
- Charities/trusts (except Arms-Length Organisations of public bodies/local authorities)
- Commercial or for-profit organisations
- Bòrd na Gàidhlig Delivery Partners

Project Timeframe

The fund will support projects which will start between 1 August 2023 and 31 March 2024 and will be fully completed by 31 August 2024.

In exceptional circumstances, an application may propose an alternative timeframe. This must be discussed and permitted by Bòrd na Gàidhlig officers prior to the application being submitted, with evidence of this permission provided along with the application.

What costs are supported?

The estimated budget allocated to this fund is £440,000. Applications may be made for up to a maximum of **£25,000 and up to 80% of project costs**. In-kind costs are permitted as part of a contribution towards total project costs.

In exceptional circumstances, projects may be awarded more than the maximum grant where it can demonstrate potential strategic or long-term benefits. Permission to apply for over £25,000 must be obtained beforehand from Bòrd na Gàidhlig officers, with evidence of this permission submitted with the application.

Applications looking to extend an existing project that was supported through GLAIF will be expected to demonstrate improvement in value for money and normalisation of Gaelic within the organisation's work over previous applications.

Cha bhi sinn a' cur taic ri cosgaisean pròiseact ri linn:

- Cosgaisean calpa
- Duaisean co-fharpais
- Cosgaisean luchd-obrach no ghoireasan air an cleachdad gus curraicealam foghlam tro mheadhan na Gàidhlig/luchd-ionnsachaich na Gàidhlig a lìbhrigeadh ann an sgoiltean, colaistean no oilthighean
- Buanachadh dreuchdan a th' ann a-cheana nach robh a' faighinn taic tro GhLAIF (ach ma tha iad an sàs ann am pròiseact ùr)
- Cosgaisean ann a bhith a' dealbhachadh, a' dèanamh co-chonaltradh air no a' foillseachadh Plana Gàidhlig

Gheibh tagraichean a tha soirbheachail 80% den tabhartas ionlan aig töiseach a' phròiseict mar as àbhaist, leis an 20% mu dheireadh air am pàigheadh às dèidh aithisg dheireannach riarrachail a bhith air a toirt seachad. Cha tèid a' chìad phàigheadh airson pròiseact 2023/24 a phàigheadh gus am bi aithisgean dheireannaich airson phròiseactan cheana agus aithisgean dearcnachaidh planaichean Gàidhlig no planaichean/dreach phlanaichean air an cur a-steach.

Riaghailtean eile

Feumaidh sibh dreach tuairisgeul(an)-obrach a chur a-steach còmhla ris an iarrtas ma tha sibh a' sireadh taic-airgid airson dreuchd, agus feumaidh Gàidhlig a bhith na sgil riatanach airson na dreuchd.

Feumaidh an tuarastal airson gach cothrom obrach air a mhaoineachadh tro Maoin Phlanaichean Gàidhlig a bhith aig ìre de cho-dhiù [Tuarastal Bìth-Beò na h-Alba de £10.90 gach uair.](#)

Ag aithneachadh taic

Mar bhuidheann poblach, tha e cudromach dhuinn gu bheil fios aig a' phoball air mar a tha sinn a' cleachdad an cuid airgid againn, is mar sin tha e cudromach gu bheil sibh ag aithneachadh gun tug Bòrd na Gàidhlig taic-airgid dhan phròiseact agaibh (far a bheil sin ionchaidh). Bidh sinn a' faighneachd san fhoirm-iarrtais mar a bhios sibh an dùil seo a dhèanamh tron phròiseact ma tha an t-iarrtas agaibh soirbheachail.

You must ensure that no other part of the project's budget is funded by money from other Bòrd na Gàidhlig funding schemes or [Bòrd na Gàidhlig's Delivery Partners](#).

We will not support project costs relating to:

- Capital costs
- Competition prizes
- Staff or resource costs used for delivering the Gaelic-medium or Gaelic-learner education curriculum in schools, colleges or universities
- Continuation of employment positions that were not previously funded by GLAIF (unless involved in a new project)
- Costs involved in developing, consulting on or publishing a Gaelic Language Plan

Successful applications will typically receive 80% of the total grant at the start of the project, with the final 20% payable pending submission of a satisfactory final report. The first payment of a 2023/24 project will only be payable once any final reports for pre-requisite projects and any outstanding Gaelic Language Plan monitoring reports or plan/draft plans requested have been submitted.

Other requirements

All projects requesting support towards funding for employment posts must include a draft job description(s) along with the application, and the position must be Gaelic-essential.

All employment opportunities funded through the Gaelic Plans Fund must pay a minimum of the [Scottish Living Wage of £10.90 per hour](#).

Acknowledgment

As a public body it is important to us that the public know where our funding is spent, and that's why it is important that you acknowledge where appropriate that Bòrd na Gàidhlig provided funding for your project. We will ask you in the application how you will acknowledge our support throughout the project if your application is successful.

Ma tha an t-iarrtas agaibh soirbheachail, bidh agaibh ri sgrùdadh is measadh a dhèanamh air mar a thèid am pròiseact agaibh a lìbhrigeadh agus a' bhuaidh aige a shealltann san aithisg dheireannaich. Feumar aithisg dheireannaich a chur a-steach airson gach pròiseact, is aithisg adhartais a chur a-steach airson gach pròiseact a bhos a' faighinn còrr is £10,000.

Aig a' char as lugha, bidh sinn ag iarraidh oirbh clàradh cia mheud duine a tha a' gabhail pàirt sa phròiseact agus faighneachd de chom-pàirtichean (no sampall de na chom-pàrtichean airson tachartasan/pròiseactan mòra) mar a bha am pròiseact na bhuanachd dhaibh a thaobh:

- Cothroman Gàidhlig a chleachdadh nas trice
- Leasachadh nan sgilean Gàidhlig aca
- Piseach a thoirt air an sunnd aca

Thèid iarraidh oirbh san fhoirm-iarrtais mar a bhos sibh an dùil sgrùdadh a dhèanamh air a' phròiseas, mar a bhos sibh a' measadh an robh am pròiseact soirbheachail is mar a bhos sibh a' trusadh fiosrachaидh bho chom-pàrtichean.

Project monitoring and evaluation

If your application is successful you will need to monitor and evaluate your project delivery and show the impact of the project in the reports. All projects must submit a final report, and all projects receiving over £10,000 must submit a progress report.

At a minimum we will ask all projects to note how many people take part in the project and to ask participants (or a sample of participants for large events/projects) how the project benefitted them in terms of:

- Their opportunity to use Gaelic more often
- Developing their Gaelic skills
- Improving their wellbeing

In the application form we will ask you how you intend to monitor the project, how you'll assess whether the project is successful, and how you will gather feedback from participants.

Reports will be available to submit via the [Fluxx application portal](#), and will be viewable if your application is approved.

Environment, Equalities, Diversity & Inclusion

Bòrd na Gàidhlig has a responsibility to promote good practice in:

Submitting an application

Applications should be submitted via our Fluxx application portal at bng.fluxx.io. An account can be registered for free on the website and it is possible to save the progress of an application whilst working on it. All supporting documents can be submitted via the portal.

The application portal will close at **3pm on Tuesday 18 April 2023** and it will not be possible to submit an application after this date.

How we will assess your application

You will receive an automatic email acknowledgment from the Fluxx portal to confirm that we have received your application. If you have not received this, please check that you have submitted your application rather than only saved it.

After the closing date for applications, Bòrd na Gàidhlig officers will then screen applications to ensure they comply with the rules of the fund and have provided necessary information. If your application is deemed ineligible, you will be asked to correct this within 10 working days, or your application will be declined.

All eligible applications will be assessed by a panel of Bòrd na Gàidhlig officers according to [the assessment guidance](#), and they will make recommendations to the Bòrd na
