Tha Bòrd na Gàidhlig a' cumail taic ri iarrtas taobh-a-muigh sgeamaichean taic-airgid àbhaisteach ma tha oifigearan riarachaidh gum bi am pròiseact a' cur ri prìomhachasan Plana Chorporra Bòrd na Gàidhlig agus gu bheil buidseat aig Bòrd na Gàidhlig air a shon.

Ar n-àrd-amas

Pròiseactan a gheibhear taic

Thèid cuireadh a thoirt seachad gus iarrtas taic-airgid coitcheann a chur a-steach ma tha am pròiseact a thathar moladh a' freagairt air amasan Bòrd na Gàidhlig mar a thathar air cur an cèill sa Phlana Chorporra 2018-23 againn agus am Plana Cànan Nàiseanta Gàidhlig 2018-23. Feumaidh oifigearan a bhith riarachaidh cuideachd gum bi buidseat gu leòr aig Bòrd na Gàidhlig gus am pròiseact maoinachadh ma tha an iarrtas soirbheachail.

About the Fund

Bòrd na Gàidhlig supports discretionary applications outwith usual funding schemes if officers are satisfied that the project will advance the priorities of Bòrd na Gàidhlig's Corporate Plan and that Bòrd na Gàidhlig has budgetary scope to do so.

For all applications outwith funding schemes, applications **must** be discussed with Bòrd na Gàidhlig officers and permission granted to make such an application, or the application will be declined.

About Bòrd na Gàidhlig

Who we are

Bòrd na Gàidhlig is the public body responsible for planning and leading the development of Gaelic language and culture in Scotland on behalf of the Scottish Government.

Our vision

That Gaelic is seen and heard on a daily basis across Scotland, such that it is widely recognised as an integral part of Scottish life and a national cultural and economic asset.

Each Bòrd na Gàidhlig funding programme is based upon the priorities as communicated in the [Bòrd's Corporate Plan 2018-2023](#), and as such it is vital that you are familiar with this plan before you submit your application.

Projects this fund will support

General funding applications will be invited by Bòrd na Gàidhlig officers if the proposed project appears to support the aims of Bòrd na Gàidhlig, as set out in our Corporate Plan 2018-23 and the National Gaelic Language Plan 2018-23. Officers must also be satisfied that Bòrd na Gàidhlig has enough remaining budget to fund the project if the application is successful.

Co dh' fhaodas tagradh a chur a-steach?

Faodaidh buidheann no neach fa-leth sam bith bruidhinn rinn aig Bòrd na Gàidhlig uair sam bith air pròiseact le amas air iarrtas a chur a-steach.

Mar pàirt den pròiseas measaidh, feumaidh bonn-stèidh a bhith aig buidhnean agus cunntas banca air an cumail ann an ainm a' bhuidheann.

Tha sinn a' moladh ma tha sibh airson iarrtas a chur a-steach gu bheil sibh toirt sùil air sgeamaichean taic-airgid a-cheana sa chiad dol a-mach air eagal is gun ghabh taic a chumail ris a' phròiseict tro sgeama.

In your application we expect you to expand on how your project meets one or more of these aims, as well as how it supports the actions of [Bòrd na Gàidhlig's Corporate Plan 2018-23](#) and the core aims that are identified in the [National Gaelic Language Plan 2018-23](#):

- Increasing Gaelic usage
- Increasing the learning of Gaelic
- Promoting a positive image of Gaelic

As part of the Faster Rate of Progress initiative, we encourage all applications to identify how their projects will succeed in delivering projects that are innovative and will seek to build partnerships with other public authorities, organisations and communities.

Applications should also consider how they can contribute to local, national and international celebrations

In assessing your application, we will be primarily looking at:

- The quality of the project and the applicant
- How clearly the project demonstrates a connection with the Bòrd na Gàidhlig Corporate Plan priorities
- The ability of your organisation to deliver the project successfully
- The strength of your plans to assess the impact of your project
- The value for money demonstrated by the project

Project Requirements

Who can apply?

Any organisation or individual can discuss a potential project with Bòrd na Gàidhlig at any time with a view to making an application.

As part of the due diligence of the application process, organisations typically must be constituted and have a bank account held in the name of the organisation.

We encourage all potential applicants to first check out existing funding schemes to see if the proposed project can be supported by a scheme.

Clàr-ama a' Phròiseict

Tha Bòrd na Gàidhlig toilichte beachdachadh air pròiseactan a tha tòiseachadh tron bhliadhna. Mar as àbhaist chan eilear toirt seachad ach maoinachadh airson aon bliadhna airson iarrtas taic-airgid, ach ma tha am buidheann air aonta taic-airgid Bòrd na Gàidhlig a choileanadh gu soirbheachail airson na phròiseict roimhe.

Tha sinn a' moladh gu bheil sibh bruidhinn ri Bòrd na Gàidhlig co-dhiù dà mhìos ron a tha sibh an dùil gun tòisich a' phròiseict gus ùine gu leòr fhàgail airson am pròiseas iarrtas.

Ìrean taic-airgid

Tha na tabhartasan coitcheann againn air taic a' chumail ri phròiseactan de iomadh diofar mheudan, agus mar sin chan eil ìre as lugha no as àirde de phròiseict a dh' fhaodas beachdachadh air. Tha sinn cuingichte a thaobh buidseat ged-tà air na ghabhas a thabhann, is bu chòir dhuibh a bhith mothachail air a seo.

Thèid fiosrachadh iarraidh air cosgaisean slàn a' phròiseict agus an t-suim a thathar an dùil a bhios a dhìth bho Bòrd na Gàidhlig mar pàirt de na chiad còmhraidhean air a' phròiseict, gus measadh a dhèanamh an ghabh taic-airgid a chumail ris.

Mar as trice tha Bòrd na Gàidhlig a' cumail taic ri phròiseactan **suas ri 80% de chosgaisean a' phròiseict**, agus a' moladh taic-airgid a' lorg bho buidhnean-maoinachaidh eile no taic neo-ionmhasail a chlàradh a dh' ionnsaigh cosgaisean a' phròiseict.

Ann an suidheachaidhean sònraichte, ged tà dh'fhaodadh gum faigh pròiseactan ìre taic nas àirde ma thathar an dùil gum bi am pròiseact a' toirt seachad buannachdan ro-innleachdail follaiseach ann a bhith libhrigeadh Plana Chorporra a' Bhùird no am Plana Cànan Nàiseanta Gàidhlig agus mar sin bidh e toirt seachad luach an airgid iomchaidh.

Tha gach pròiseact air am maoinachadh air stèidh rèidh, agus ma tha taic-airgid Bòrd na Gàidhlig ann nach deach a chleachdadh air pròiseact gun tèid sin tilleadh thugainn

Bhithear an dùil gum bi pròiseactan a tha air taic fhaighinn bho Bòrd na Gàidhlig a-cheana a' sealltainn adhartas ann an luach an airgid agus àbhaisteachadh na Gàidhlig ann an obair na buidhne thairis air iarrtasan a bh' ann a-cheana, agus bu chòir gum bithear an dùil taic-airgid fhaighinn air slighe a tha lùghdachadh.

Project Timeframe

Bòrd na Gàidhlig is happy to discuss projects that start at different times of year. We will typically provide funding for a maximum of one year through one funding application, unless there is previous evidence of having successfully fulfilled a Bòrd na Gàidhlig funding agreement for the project in the past.

We recommend that you discuss your project with Bòrd na Gàidhlig at least two months before the intended start date to allow sufficient time for the application process.

Funding levels

Our general grants have supported projects of all sizes, and as such there is no minimum or maximum project size that can be discussed. However, we are limited by budget in what we can provide and this should be taken in to account.

Officers will request information on the total project costs and the estimate required from Bòrd na Gàidhlig as part of the initial discussions on the project, to assess whether the project can be supported.

Typically Bòrd na Gàidhlig will only support **up to 80% of total project costs**, and recommend sourcing match funding from other funders or including in-kind costs as part of the contribution to project costs.

In exceptional circumstances however the Bòrd may support a higher rate of support if the project is deemed to have a significant strategic benefit in delivering the Bòrd's Corporate Plan or the National Gaelic Language Plan and as such would provide sufficient value for money.

All projects are also funded on a break-even basis, so that any Bòrd na Gàidhlig funding that is not utilised in completion of the project is returned to us.

Applications looking to extend an existing project supported by Bòrd na Gàidhlig funding will be expected to demonstrate improvement in value for money and normalisation of the project's work within the organisation, and should typically expect to receive funding on a sliding scale of support.

Gheibh tagraichean a tha soirbheachail 80% den tabhartas iomlan aig tòiseach a' phròiseict mar as àbhaist, leis an 20% mu dheireadh air am pàigheadh às dèidh aithisg dheireannach riarachail a bhith air a toirt seachad. Cha tèid a' chiad phàigheadh airson pròiseact a phàigheadh gus a bheil aithisgean dheireannaich airson pròiseactan cheana air a bhith an cur a-steach.

Riaghailtean eile

Feumaidh sibh dreach tuairisgeul(an)-obrach a chur a-steach còmhla ris an iarrtas ma tha sibh a' sireadh taic-airgid airson dreuchd, agus feumaidh Gàidhlig a bhith na sgil riatanach airson na dreuchd.

Ag Aithneachadh Taic

Airson an sgeama seo, feumaidh sibh aithne a thoirt (nuair a tha sin iomchaidh) don taic-airgid a fhuair sibh bho Bhòrd na Gàidhlig airson a' phròiseict agaibh mar pàirt den sanasachd agaibh.

Airson tuilleadh fiosrachaidh nach toir sibh sùil air an [Stiùireadh Aithneachaidh](#) is [Stiùireadh Brannd](#) air an làrach-lìn againn.

Sgrùdadh is measadh air a' phròiseact

Bidh aig gach pròiseact soirbheachail ri sgrùdadh is measadh a dhèanamh air mar a thèid am pròiseact aca a libhrigeadh agus feumaidh iad fianais a thoirt seachad air an sin ann an aithisgean adhartais agus no deireannaich aca.

Bidh aig gach pròiseact a gheibh còrr is £10,000, no ris a bheilear an dùil a bhios maireachdainn nas fhaide na 12 mìosan, ri aithisg adhartais a chur a-steach agus bidh aig gach pròiseact ri aithisg dheireannaich a chur a-steach.

Aig a' char as lugha, bidh sinn ag iarraidh oirbh clàradh cia mheud duine a tha a' gabhail pàirt sa phròiseact agus

You must ensure that no other part of the project's budget comes from other Bòrd na Gàidhlig funding schemes or regular funding programmes.

We will not support project costs relating to:

- Capital costs
- Competition prizes
- Staff or resource costs used for delivering the Gaelic-medium education curriculum
- Costs involved in developing, consulting on or publishing a Gaelic Language Plan

Successful applications will typically receive 80% of the total grant at the start of the project, with the final 20% payable pending submission of a satisfactory final report. The first payment for a project will only be payable once any final reports for pre-requisite projects have been submitted.

Other requirements

All projects requesting support towards funding for employment posts must include a draft job description(s) along with the application, and the position must be Gaelic-essential.

Acknowledgment

For this funding programme, you must acknowledge (where appropriate) that Bòrd na Gàidhlig were a source of funding for your project as part of your publicity efforts.

Project monitoring and evaluation

All successful projects will be required to monitor and evaluate their project delivery and provide evidence of this in progress and/or final reports.

Each project that receives over £10,000, or has a planned duration of over 12 months, will need to submit a progress report and all projects must submit a final report.

At a minimum we will ask all projects to note how many people take part in the project and to ask participants (or a

Fair Work

Organisations in receipt of public funding in Scotland are required to adhere to the Scottish Government's Fair Work First policy, and as such **must**:

- Pay at least the real Living Wage; and

- Dòighean iomchaidh airson guth luchd-obrach èifeachdach, leithid aithneachadh aonaidhean-ciùird, a chruthachadh

Agus thathar gam brosnachadh gu làidir:

- Tasgadh ann an leasachadh luchd-obrach

Submitting an application

You should get in touch with Bòrd na Gàidhlig via email at tabhartas@gaidhlig.scot as soon as possible if you have an idea for a project that you believe would be suitable for Bòrd na Gàidhlig funding.

Officers will then discuss your project idea with you and determine whether it is suitable for funding. If officers deem the project suitable, you will be invited to submit an application via our online grants portal, Fluxx, at bng.fluxx.io. An account can be registered for free on the website and it is possible to save the progress of an application whilst working on it. All supporting documents can be submitted via the portal.

Please note, Bòrd na Gàidhlig may request additional information or clarification of project details at initial contact or after the application has been submitted.

How we will assess your application

You will receive an automatic email acknowledgment from the Fluxx portal to confirm that we have received your application. If you have not received this, please check that

Bòrd na Gàidhlig officers will then screen applications to ensure they have provided necessary information and has been previously permitted. If your application is deemed ineligible, you will be asked to rectify this within 10 working days, or your application will be declined.

All eligible applications will be assessed by a panel of Bòrd na Gàidhlig officers according to [the assessment guidance](#) within three weeks of the application's submission, and they will provide recommendations to the Senior Management Team for decision at their next meeting (which occur every six weeks). If the SMT recommend a funding award of over £50,000 the application must be approved by the Bòrd's Policy and Resources Committee, and if the recommended award is over £100,000 it must be approved by the Board.

All applicants should be informed of the decision of the Senior Management Team no later than eight weeks from the date of submission. However, a final decision may take longer if approval of the Policy and Resources Committee or Board is required, depending on the timetable for meetings (of which Bòrd na Gàidhlig officers will advise at the point of application).
