**FINANCE****Finance Report to 31/07/2023**

NP provided Members with an overview of the finance report. Members were told that, while £168,000 behind budget at the time of the meeting, a full spend of the budget was reflected through commitments. A verbal update to the end of September was given and it was reported that BnG were now slightly ahead of budget.

Members asked if this was a healthy position to be in at this stage and NP confirmed that this was within budget and going in the correct direction.

Members asked for further information on reclaimed funding. NP explained that reclaimed funding is returned when recipients do not use their full award, and that this would subsequently be re-allocated to its original funding stream.

**3.0 PLANA GNÌOMH IS COILEANADH**

**3.1 PCCs 2023/24 – Sgrùdadh**

Dh'fhaighnich Buill dè am beachd a bh' aig buidhnean com-pàirteachaidh air PCC 2. Dh'aithris IMM gun robh iad toilichte cluinntinn gum biodh seo a' tachairt. Chaidh innse mun àireimh de dh'iarrtasan a chaidh a chur a-steach agus mu chuid de na duilgheadas a dh'fhaodadh èirigh. Thuirt IMM cho cudromach 's a bhios e gun tig fianais bho buidhnean gus am faicear luach an airgid. **OPERATIONAL PLAN AND PERFORMANCE**

**KPIs 2023/24 – Monitoring**

IMM told Members that the paper showed the progress of the work of Bòrd na Gàidhlig, although the National Gaelic Language Plan 2023-28 and Corporate Plan 2023-24 had not yet been approved. He told Members that a discussion on this topic was held at the Policy and Resources Committee.

Members asked how stakeholder groups felt about KPI 2. IMM indicated that they were pleased to hear that this would be happening. Information was given about the number of applications submitted and about some of the problems that may arise. IMM raised how important it would be that evidence is received from organisations so that the value of the money can be identified. It is expected that it will be a big change and that it will make a big difference for the partner organisations. IMM explained that it will be a difficult piece of work and that it is expected that recommendations would be presented to the Board in December.

The Ceannard told Members that it could be seen that there would be opportunities in the process and that people would have strong opinions. She told Members that she was looking forward to working with the team and that a draft Corporate Plan will be presented to the Board following publication of the National Gaelic Language Plan 2023-28.

**3.2 Adhartas nas Luaithe**

Chaidh beachdachadh air a' bhuidhinn a bhiodh ann nan robh Gàidhlig na pàirt àbhaisteach de gach buidheann aig ìre Riaghaltais, agus mar a bheireadh seo taic do prìomhachasan Bhòrd na Gàidhlig ann a bhith a' toirt air adhart na Gàidhlig.

Dh'fhaighnich Buill an robh na bursaraidhean STEM air a bhith soirbheachail. Thuir JMH gun robh ùidh air a bhith ann, agus gum bithear ag obair le co-obraichean airson beachdachadh air mar as urrainn don sgeama obrachadh san dòigh as fheàrr. Thugadh fa-near cho cudromach 's a bhios e gum bi obraichean rim faighinn às dèidh làimh. Bha Buill den bheachd gu bheil cothrom ann do Bhòrd na Gàidhlig agus Riaghaltas na h-Alba fios a sgoileadh air an àireimh de dhaoine a tha a' faighinn bursaraidh STEM.

Chaidh còmhradh a chumail mu dè am fiosrachadh a bhios Bòrd na Gàidhlig a' faighinn mu dheidhinn oileanaich a tha a' trèanadh gu bhith nan tidsearan. Thug JMH fios gu bheil e mar phàirt de obair Bhòrd na Gàidhlig dàimhean a thogail eadar oilthighean is buidhnean a tha an sàs ann am foghlam thidsearan. Cha bhi oilthighean ag aithris air àireamhan oileanaich gu dìreach do BnG.

Thugadh beachdan seachad mu dhuilgheadasan agus fuasglaidhean, mar eisimpleir cùmhnantan agus a bhith a' faighinn obair às dèidh na bliadhna pròbhaidh.

**Faster Rate of Progress**

JMH gave background information to the new Members on the Faster Rate of Progress group led by Scottish Government and clarified a date error in the document.

The effects that would be seen if Gaelic was a normalised part of every organisation at Government level and how this would support the priorities of Bòrd na Gàidhlig in promoting the Gaelic language was discussed.

Members asked if the STEM bursaries had been successful. JMH told Members that there had been interest, and that work with colleagues would continue to discuss how the scheme could work in the best way possible. It was noted how important it would be for jobs to be made available for those who qualify. Members considered that there was an opportunity for Bòrd na Gàidhlig and Scottish Government to share information on the number of people receiving STEM bursaries.

A discussion was held about what information Bòrd na Gàidhlig receives about students who are training to become teachers. JMH explained that it was a part of Bòrd na Gàidhlig's work to build relationships between universities and organisations involved in teacher education. Universities do not report on student numbers direct to BnG.

Members asked for an overview on what would be required for the success of Gaelic teaching and JMH told them that many of the problems faced are the same in the teaching of English but that the effects can be worse in Gaelic Medium Education due to lower number of teachers compared to English medium. Opinions were provided about some problems and solutions, for example contracts and finding work after probationary years.

Members asked if there was progress to be seen from the work of Faster Rate of Progress. IMM replied that information on this had not been collected but it is believed that there has been progress, and he noted that it is necessary to focus on the problems that are emerging.

that the new presentation of the register came from a recommendation following risk training for Board Members and Leadership Team in March 2023.

Members raised that it was not clear whether the gross score was reflecting before or after current controls were put in place. NP to review and return to Members with an answer.

Members discussed how often 'unacceptable risks' should be presented to the Board. NP told Members that these are reviewed every nine weeks by the Leadership Team and suggested that red and orange risks be presented to the Board. StML, Chair of the Audit & Assurance Committee, assured Members that the Committee had discussed what was acceptable or unacceptable in terms of risk and how these could be defined. It was noted that the Committee had suggested the addition of a 'risk appetite' column to reflect the context of the organisations risk appetite rather than applying further controls. It was suggested that it could be clarified in the proposed action that the risk would be reviewed at Board level more frequently.
