

Stiùireadh Maoin Phlanaichean Gàidhlig – Sruth Phròiseactan 2024/25 Gaelic Plans Fund – Projects Stream 2024/25 Funding Guidelines

Mu dheidhinn na Maoin

Tha Maoin Phlanaichean Gàidhlig (air an robh roimhe GLAIF) airson ùghdarrasan poblach a chuideachadh gus na Planaichean Gàidhlig reachdail aca a chur an gnìomh agus taic a chur ri Plana Nàiseanta na Gàidhlig 2023-28 ùr. Tha ùghdarrasan poblach cuideachd air taic-airgid fhaighinn tro Mhaoin Phlanaichean Gàidhlig gus pròiseactan a thoirt gu buil mus tèid iarraidh orra gu foirmeil Plana Gàidhlig a sgrìobhadh.

Bho 2024, tha dà shruth maoin eachaidh eadar-dhealaichte ri fhaighinn tron Mhaoin Phlanaichean Gàidhlig:

- An Sruth Ro-innleachdail – do na 6 ùghdarrasan ionadail air am meas cudromach
- An Sruth Phròiseactan – airson ùghdarrasan poblaich eile le planaichean Gàidhlig

Tha an stiùireadh seo a’ buntainn ris an t-sruth Phròiseactan a-mhàin, le stiùireadh airson an t-sruth Ro-innleachdail ri fhaighinn air an làrach-lìn againn sa Mhàirt 2024.

Anns an iarrtas agaibh tha sinn an dùil gun inns sibh mar a bhios am pròiseact agaibh a’ cur an gnìomh am [Plana Nàiseanta na Gàidhlig 2023-28](#) ùr agus an t-eagraan fhoillsichte de phlana Ghàidhlig an ùghdarras agaibh.

Ann a bhith a’ measadh an iarrtais agaibh, bidh sinn a’ coimhead gu sònraichte air:

- Inbhe a’ phròiseict san fharsaingeachd is a’ bhuidhe a’ fhaodadh a bhith aige air àrdachadh cleachdadh no ionnsachadh na Gàidhlig
- Luach an airgid a tha ga shealltainn leis a’ phròiseict
- An ìre de dh’ùr-ghnàthachas is obair com-pàirteachais air a chur an cèill san iarrtas
- Comas na buidhne agaibh am pròiseact libhrigeadh gu soirbheachail
- Neart nam planaichean agaibh gus buaidh a’ phròiseict agaibh a mheasadh

About the Fund

The Gaelic Plans Fund (formerly named GLAIF) is available to help public authorities in the delivery of commitments in their statutory Gaelic Language Plans, and in support of the new National Gaelic Language Plan 2023-28. The Gaelic Plans Fund has also been used to assist other public authorities in the delivery of projects ahead of their formal notice to produce a Gaelic Language Plan.

From 2024, there are two separate funding streams available through the Gaelic Plans Fund:

- The Strategic Stream – for 6 local authorities deemed significant
- The Projects Stream – for all other public authorities with Gaelic language plans

This guidance relates to the Projects stream only, with guidance on the Strategic stream available on our website from March 2024.

In your application we expect you to expand on how your project will help implement the [new National Gaelic Language Plan 2023-28](#) and the currently published edition of your authority’s Gaelic language plan.

Further to this, in assessing your application, we will also be looking at:

- The overall quality of the proposed project and its potential impact on increasing the use and learning of Gaelic
- The value for money demonstrated by the project
- The level of innovation and partnership working shown in the application
- The ability of your authority to deliver the project successfully
- The strength of your plans to assess the impact of your project

Sruth Phròiseactan – Riaghailtean

Cò dh'fhaodas iarrtas a chur a-steach?

Tha Sruth Phròiseactan den Mhaoin Phlanaichean Gàidhlig fosgailte do dh'ùghdarrasan poblach/ionadail aig a bheil plana Gàidhlig fhoillsichte, a tha anns a' phròiseas a bhith ullachadh a' chiad phlana Gàidhlig aca, no a fhuair fios bho Bhòrd na Gàidhlig gum feum iad plana Gàidhlig ullachadh fo Achd na Gàidhlig (Alba) 2005.

Chan fhaod na 6 ùghdarrasan ionadail aig a bheil cead iarrtas a chur a-steach tron t-Sruth Ro-innleachdail iarrtas a chur a-steach don t-Sruth Phròiseactan, is iad:

- Comhairle nan Eilean Siar
- Comhairle na Gàidhealtachd
- Comhairle Earra-Ghàidheal is Bhòid
- Comhairle Baile Ghlaschu
- Comhairle Baile Dhùn Èideann
- Comhairle Siorrachd Lannraig a Tuath

Chaidh na h-ùghdarrasan seo air am meas cudromach leis an àireamh de luchd-labhairt na Gàidhlig a tha fuireach anns na sgìrean aca a-rèir na figearan cunntas-sluaigh mu dheireadh ri fhaighinn, an àireamh de sgoilearan ann am foghlam tro mheadhan na Gàidhlig anns na sgìrean agus taic tro chuaritean Maoin Phlanaichean Gàidhlig/GLAIF roimhe. Chan fhaod buidhnean leth-eisimeileach aig ùghdarrasan le phlana Gàidhlig iarrtas a chur a-steach am bliadhna tron mhaoin. Faodaidh iad obair còmhla ris na h-ùghdarrasan dham buin iad ge-tà gus an cuir an t-ùghdarras iarrtas a-steach air an son.

Tha fàilte air iarrtasan bho bhuidhnean ag obair còmhla, ach bu chòir na h-iarrtasan seo prìomh bhuidheann ainmeachadh airson a' chùmhnaidh taic-airgid.

Gheibhear eisimpleirean de phròiseactan a fhuair taic bhon sgeama seo a-cheana (a' gabhail a-steach GLAIF) [tron làrach-lìn GrantNav.](#)

Faodaidh buidhnean suas ri 3 iarrtasan a chur a-steach don sruth Phròiseactan am-bliadhna, ach bidh am Bòrd ag amas air taic a chumail ri caochladh bhuidhnean poblach air feadh Alba is mar sin faodar gun tèid co-dhùnadh an àireamh de phròiseactan maoinichte aig gabh buidheann a chasg a-rèir bhuidseat.

Projects Stream – Requirements

Who can apply?

The Projects Stream of the Gaelic Plans Fund is open to Scottish public/local authorities who currently have a published Gaelic language plan, are in the process of developing their first Gaelic language plan, or have been served notice by Bòrd na Gàidhlig that they must develop a Gaelic language plan under the Gaelic Language (Scotland) Act 2005.

The 6 local authorities who are eligible to apply through the Strategic Stream are not eligible to apply via the Projects Stream, which are:

- Comhairle nan Eilean Siar
- The Highland Council
- Argyll and Bute Council
- Glasgow City Council
- City of Edinburgh Council
- North Lanarkshire Council

These local authorities were deemed significant due to their overall number of Gaelic speakers according to the most recent census figures available, the number of pupils they have in Gaelic-medium education and previous support provided to them via the Gaelic Plans Fund/GLAIF. Arms-length organisations (ALEOs) of authorities with a Gaelic language plan **cannot** apply through the fund this year. ALEOs can however work with authorities to which they belong so that the authority can apply on their behalf.

Joint applications between organisations are welcomed, although such applications should identify a lead organisation for contractual purposes.

Organisations may submit up to a maximum of 3 applications to this year's Projects Stream. However, Bòrd na Gàidhlig will aim to support as wide a range of bodies across Scotland as possible so may decide to limit the number of projects awarded per organisation depending on budget.

Mar sin, bu chòir nì sam bith a tha a dhìth airson diofar phròiseactan a libhrigeadh (m.e. ùine luchd-obrach) a bhith air a chur a-steach gu co-rèireach anns gach iarrtas, agus feumar dearbhadh cuideachadh nach eil nì air a mhaoineachadh dà thuras.

Cò nach faodadh tagradh a chur a-steach?

- Daoine fa-leth
- Buidhnean coimhearsnachd
- Carthannasan/urrahan (nach eil nan ùghdarrasan ionadail)
- Buidhnean coimearsalta/airson prothaid
- Buidhnean Com-pàirteach Libhrigidh Bòrd na Gàidhlig

Clàr-ama a' Phròiseict

Bidh an sgeama a' toirt taic do phròiseactan thòisicheas eadar 1 Lùnastal 2024 agus 31 Màrt 2025 agus a thèid crìochnachadh ro 31 Lùnastal 2025.

Ann an suidheachaidhean sònraichte, faodaidh iarrtas clàr-ama eadar-dhealaichte a mholadh. Feumaidh conaltradh a bhith ann air seo le oifigearan a' Bhùird agus cead a bhith air a thoirt seachad mus tèid an t-iarrtas a chur a-steach, le fianais air a' chhead seo air a thoirt seachad an cois an iarrtais.

Dè na cosgaisean a gheibh taic?

'S e £170,000 am buidseat ris a bheilear an dùil airson an Sruth Ro-innleachdail. Faodar iarrtasan airson pròiseactan a chur a-steach airson suas ri **£25,000** agus **suas ri 80% de chosgaisean a' phròiseict**. Tha cosgaisean neo-ionmhasail ceadaichte mar phàirt de chosgaisean iomlan a' phròiseict.

Bhithear an dùil gum bi pròiseactan a bha air taic fhaighinn tro chuirtean Maoin Phlanaichean Gàidhlig a-cheana a' sealltainn adhartas ann an luach an airgid agus àbhaisteachadh na Gàidhlig ann an obair na buidhne thairis air iarrtasan a bh' ann a-cheana.

Thathar an dùil gum tèid ìre nas isle de thaic-airgid an taca ri bliadhnaichean roimhe air a thabhann do dh' iarrtasan soirbheachail airson dreuchdan a chaidh a mhaoineachadh tron Mhaoin Phlanaichean Gàidhlig, gus an obair seo àbhaisteachadh taobh a-staigh ùghdarrasan.

Bu chòir dhuibh dèanamh cinnteach nach eil pàirt sam bith eile de bhuidseat a' phròiseict air am maoineachadh tro sgeamaichean maoineachaidh eile agus nach eil maoineachadh dùbailte ann le phròiseactan far a bheil [Buidhnean Com-pàirteach Libhrigidh Bhòrd na Gàidhlig](#) an sàs.

As such, any element that is required for the delivery of multiple projects (e.g. staff time) must be included proportionally in each application, whilst ensuring that there is no duplicate funding requested.

Who cannot apply?

- Individuals
- Community groups
- Charities/trusts (that are not public bodies)
- Commercial or for-profit organisations
- Bòrd na Gàidhlig Delivery Partners

Project Timeframe

The fund will support projects which will start between 1 August 2024 and 31 March 2025 and will be fully completed by 31 August 2025.

In exceptional circumstances, an application may propose an alternative timeframe. This must be discussed and permitted by Bòrd na Gàidhlig officers prior to the application being submitted, with evidence of this permission provided along with the application.

What costs are supported?

The estimated budget allocated to this Projects Stream is £170,000. Applications may be made for up to a maximum of **£25,000** and **up to 80% of project costs**. In-kind costs are permitted as part of a contribution towards total project costs.

Applications looking to extend an existing project that was supported through previous Gaelic Plans Fund rounds will be expected to demonstrate improvement in value for money and normalisation of Gaelic within the organisation's work over previous applications.

It is expected that applications towards employment posts previously funded by the Gaelic Plans Fund will, if successful, be awarded a decreased level of support compared with previous years to promote the normalisation of work within authorities.

You must ensure that no other part of the project's budget is funded by money from other Bòrd na Gàidhlig funding schemes and that there is no double-funding of projects involving [Bòrd na Gàidhlig's Delivery Partners](#).

Cha bhi sinn a' cur taic ri cosgaisean pròiseact ri linn:

- Cosgaisean calpa
- Duaisean co-fharpais
- Cosgaisean luchd-obrach no ghoireasan air an cleachdadh gus curraicealam foghlam tro mheadhan na Gàidhlig/luchd-ionnsachaidh na Gàidhlig a libhrigeadh ann an sgoiltean, colaistean no oilthighean
- Buanachadh dreuchdan a th' ann a-cheana nach robh a' faighinn taic tron Mhaoin Phlanaichean Gàidhlig (ach ma tha iad an sàs ann am pròiseact ùr)
- Cosgaisean ann a bhith a' dealbhachadh, a' dèanamh co-chonaltradh air no a' foillseachadh Plana Gàidhlig

Thèid iarraidh oirbh anns an iarrtas agaibh cuin a bhios sibh an dùil ris an airgead agaibh a chosg, is cleachdaidh sinn seo airson pròifil pàighidh a chur air dòigh san aonta taic-airgid air nuair a thèid ur pàigheadh. Cha tèid a' chiad phàigheadh airson pròiseact 2024/25 a phàigheadh gus am bi aithisgean deireannach airson phròiseactan cheana agus aithisgean dearcnachaidh phlanaichean Gàidhlig no planaichean/dreach phlanaichean air an cur a-steach.

Riaghailtean eile

Feumaidh sibh dreach tuairisgeul(an)-obrach a chur a-steach còmhla ris an iarrtas ma tha sibh a' sireadh taic-airgid airson dreuchd, agus feumaidh Gàidhlig a bhith na sgit riatanach airson na dreuchd.

Feumaidh an tuarastal airson gach cothrom obrach air a mhaoinachadh tro Maoin Phlanaichean Gàidhlig a bhith aig ìre de cho-dhiù [Tuarastal Bith-Beò na h-Alba de £12 gach uair](#).

Ag aithneachadh taic

Mar bhuidheann poblach, tha e cudromach dhuinn gu bheil fios aig a' phoball air mar a tha sinn a' cleachdadh an cuid airgid againn, is mar sin tha e cudromach gu bheil sibh ag aithneachadh gun tug Bòrd na Gàidhlig taic-airgid dhan phròiseact agaibh (far a bheil sin iomchaidh). Bidh sinn a' faighneachd san fhoirm-iarrtais mar a bhios sibh an dùil seo a dhèanamh tron phròiseact ma tha an t-iarrtas agaibh soirbheachail.

Airson tuilleadh fiosrachaidh, nach toir sibh sùil air an [Stiùireadh Aithneachaidh](#) is [Stiùireadh Brannd](#) air an làrach-lìn againn.

We will not support project costs relating to:

- Capital costs
- Competition prizes
- Staff or resource costs used for delivering the Gaelic-medium or Gaelic-learner education curriculum in schools, colleges or universities
- Continuation of employment positions that were not previously funded by the Gaelic Plans Fund (unless involved in a new project)
- Costs involved in developing, consulting on or publishing a Gaelic Language Plan

You will be asked in your application to provide a profile as to when you expect to spend your funding, which we will use to set a payment profile for your grant agreement. The first payment of a 2024/25 project will only be payable once any final reports for pre-requisite projects and any outstanding Gaelic Language Plan monitoring reports or plan/draft plans requested have been submitted.

Other requirements

All projects requesting support towards funding for employment posts must include a draft job description(s) along with the application, and the position must be Gaelic-essential.

All employment opportunities funded through the Gaelic Plans Fund must pay a minimum of the [Scottish Living Wage of £12 per hour](#).

Acknowledgment

As a public body it is important to us that the public know where our funding is spent, and that's why it is important that you acknowledge where appropriate that Bòrd na Gàidhlig provided funding for your project. We will ask you in the application how you will acknowledge our support throughout the project if your application is successful.

Ma tha an t-iarrtas agaibh soirbheachail, bidh agaibh ri sgrùdadh is measadh a dhèanamh air mar a thèid am pròiseact agaibh a libhrigeadh agus a' bhuaidh aige a shealltainn san aithisg dheireannaich. Thèid iarraidh oirbh san fhoirm-iarrtais mar a bhios sibh an dùil sgrùdadh a dhèanamh air a' phròiseas, mar a bhios sibh a' measadh an robh am pròiseact soirbheachail is mar a bhios sibh a' trusadh fiosrachaidh bho chom-pàirtichean.

Bidh e comasach dhuibh aithisgean a chur a-steach tro [phortal iarrtasan Fluxx](#), agus bidh e comasach seo fhaicinn ma tha an t-iarrtas agaibh soirbheachail.

Àrainneachd, Co-ionannachd, Iomadachd & Inghabhalachd agus Obair Chothromach

Project monitoring and evaluation

If your application is successful you will need to monitor and evaluate your project delivery and show the impact of the project in the reports. All projects must submit a final report, and all projects receiving over £10,000 must submit a progress report.

In the application form we will ask you how you intend to monitor the project, what targets/KPIs you will set and how you'll assess whether the project is successful, and how you will gather feedback from participants of the impact.

Reports will be available to submit via the [Fluxx application portal](#), and will be viewable if your application is approved.

Environment, Equalities, Diversity & Inclusion and Fair Work

Bòrd na Gàidhlig has a responsibility to promote good practice in:

- Reducing impact on the environment

- Co-dhiù am fìor Thuarastal Beò a phàigheadh; agus
- Dòighean iomchaidh airson guth luchd-obrach èifeachdach, leithid aithneachadh aonaidhean-ciùird, a chruthachadh

Agus thathar gam brosnachadh gu làidir:

- Tasgadh ann an leasachadh luchd-obrach
- Dèan gnìomh gus dèiligeadh ris a' bheàrn pàighidh gnè agus cruthaich àite-obrach nas eadar-mheasgte agus nas in-ghabhalach

Fair Work

Organisations in receipt of public funding in Scotland are required to adhere to the Scottish Government's Fair Work First policy, and as such **must**:

- Pay at least the real Living Wage; and
- Provide appropriate channels for effective workers' voice, such as trade union recognition

And are strongly encouraged to:

- Invest in workforce development
- Take action to tackle the gender pay gap and create a more diverse and inclusive workplace
- Offer flexible and family-friendly working practices for all workers from day one of employment; and
- Oppose the use of fire and rehire practice

You will be asked as part of your application and reporting to confirm that you are adhering to the policy and provide evidence of doing so.

Submitting an application

Applications should be submitted via our Fluxx application portal at bng.fluxx.io. An account can be registered for free on the website and it is possible to save the progress of an application whilst working on it. All supporting documents can be submitted via the portal.

The application portal will close at **3pm on Thursday 18 April 2024** and it will not be possible to submit an application after this date unless permission has been provided prior to the deadline by Bòrd na Gàidhlig officers.

Gheibh sibh post-d fèin-obrachail bhon phortal Fluxx a' dearbhadh gun d' fhuair sinn an t-iarrtas agaibh. Mur eil sibh air seo fhaighinn, dèanaibh cinnteach gu bheil sibh air an t-iarrtas agaibh a chur a-steach is nach eil sibh dìreach air a shàbhaladh.

Às dèidh a' chinn-uidhe airson iarrtasan a chur a-steach, thèid sgrùdadh a dhèanamh air iarrtasan le oifigearan Bhòrd na Gàidhlig gus dearbhadh gu bheil iad a' leantainn riaghailtean na maoin agus gu bheil iad a' toirt seachad an fhiosrachaidh a tha a dhìth. Ma thathar den bheachd nach eil an t-iarrtas agaibh ceadaichte, thèid iarraidh oirbh seo a chur ceart taobh-a-staigh 5 làithean-obrach, no thèid an t-iarrtas agaibh a dhiùltadh.

How we will assess your application

You will receive an automatic email acknowledgment from the Fluxx portal to confirm that we have received your application.

After the closing date for applications, Bòrd na Gàidhlig officers will then screen applications to ensure they comply with the rules of the fund and have provided necessary information. If your application is deemed ineligible, you will be asked to correct this within 5 working days, or your application will be declined.

All eligible applications will be assessed by a panel of Bòrd na Gàidhlig officers according to [the assessment guidance](#), and they will make recommendations to the Bòrd na Gàidhlig Senior Management Team who will decide on the outcome of applications.

Bòrd na Gàidhlig may request additional information or clarification of project details as part of the assessment process.

You will be informed of the result of your application via email in June 2024.

Thereafter, a funding agreement will be sent via Docusign to your nominated signatories. You will have up to 30 days from the date of issue to sign and return the funding agreement or the offer shall lapse.

If you are not satisfied with the outcome of your application, while we do not offer an appeal process you may make a complaint if you believe your application has not been dealt with in accordance with this guidance and the assessment guidance.
