Staff Recruitment and Succession Planning

SB provided an overview of the Staff Recruitment and Succession Planning Review which received a weak level of assurance. She provided Members with information on the purpose and scope of the review. Two high-grade, three medium grade recommendations and five areas of good practice were raised. SB provided information on each recommendation and the critical points.
