

Stiùireadh-measaidh Maoin Phlanaichean Gàidhlig – Sruth Phròiseactan 2026/27 Gaelic Plans Fund – Projects Stream 2026/27 Assessment Guidance

Sgrùdadh ro-mheasaidh air iarrtasan / Pre-assessment application screening

Bu chòir gun tèid gach iarrtas a sgrùdadh mus tèid e airson measadh gu dearbhadh gu bheil e a' leantainn riaghailtean an sgeama mar [a tha ann san stiùireadh](#). Mur eil e a' leantainn nan riaghailtean a leanas, bu chòir gun tèid iarraidh air n neach-iarrtais na mearachdan a cheartachadh ro **10m air Dimàirt 12 Cèitean 2026**, no faodar an t-iarrtas a dhiùltadh gun mheasadh.

Each application should be screened before assessment to ensure it follows the rules of the scheme set out [in the guidance](#). If it does not follow the rules below, the applicant should be asked to correct any errors by **10am on Tuesday 12 May 2026**, or the application may be declined without assessment.

- Buidheann na ùghdarras poblach/ionadail le plana Gàidhlig reachdail, is air a chumail ri dleasan fon Achd
- Iarrtas taic-airgid airson £20,000 no nas lugha (no le cead ro-làimh)
- Iarrtas taic-airgid aig no nas lugha na 80% de chosgaisean iomlan a' phròiseict
- Teachd-a-steach agus cosgaisean slàn airson a' phròiseict ri fhaighinn
- Pròiseact a' tòiseachadh eadar an Lùnastal 2026 agus Faoilleach 2027 (no le cead airson ceann-là eile)
- Pròiseact a' crìochnachadh rè no ron Sultain 2027 (no le cead airson ceann-là eile)
- Organisation is a public/local authority with a statutory Gaelic language plan, and up-to-date with responsibilities under the Act
- Funding request of £20,000 or under (unless previously permitted)
- Funding request at or under 80% of total project costs
- Full projected income and expenditure outlined
- Project begins between August 2026 and January 2027 (or with alternative date permitted)
- Project ends during or before September 2027 (or with alternative date permitted)

Molaidhean airson sgòradh fa-leth / Individual scoring recommendations

Bu chòir gach ball den phannal nochdadh aig a' chiad chothrom ùidh sam bith ann an gin de na h-iarrtasan tron sgeama. Ma tha ùidh aig ball ann an gin de na h-iarrtasan, cha bu chòir dhaibh an t-iarrtas sin a mheasadh.

Any panel member should register any interest they may have in any of the scheme's application as soon as possible. If a panel member has an interest in any application, they should not assess that application.

Bu chòir gach ball den phannal na h-iarrtasan a sgòradh a rèir an stiùiridh gu h-ìosal. Thathar an dùil gum bi sgòr de cho-dhiù 60% gu h-iomlan a dhìth mar as trice airson iarrtas a bhith airidh air moladh taic-airgid.

Each individual panel member should score applications in accordance to the guidance below. It is expected that a score of at least 60% overall is typically required for an application to be eligible for a funding recommendation.

Bu chòir gach puing-measaidh a bhith air a sgòradh a-mach à 5, le stiùireadh gu h-ìosal air na tha gach sgòr a' comharrachadh. Ma tha stiùireadh sònraichte ann airson puing-measaidh, bu chòir sin a bhith ga mheas mar phrìomhachais.

Each assessment criteria should be scored out of 5, with guidance below on what each score represents. However, if there is specialist guidance provided then that should be considered as a priority.

Social Responsibilities

- How much of an environmental impact will the project have (particularly with regard to travel)?
- Does the application show how the project will attempt to minimise its environmental impact?
- Does the application provide opportunities for young people in care, and if so, how well does it consider their needs?
- Does the application show awareness of responsibilities in terms of equalities and provide opportunities to engage with Gaelic for people under protected characteristics?

If no answer is provided score 1. If the application shows appropriate consideration of the questions but that it will not specifically offer opportunities in relation to Corporate Parenting & equalities, then score 3. If the application does not consider all of the environment, equalities and Corporate Parenting the maximum score is 4.

Bidh sgòr iomlan an uair sin air a ruighinn le bhith ag iomadachadh sgòr a-mach à 5 airson gach slat-tomhais le cuideam gach slat-tomhais, agus iad seo a chur còmhla, mar a chithear san eisimpleir gu h-ìosal.

A final score is then provided by multiplying each criteria's score out of 5 by the weight of each criteria, and adding these together, as exemplified below:

Measadh mar phannal / Panel assessment

Às dèidh do bhuill a' phannail na h-iarrtasan a mheasadh, thig iad còmhla gus aonta a ruighinn air:

- A bheilear a' moladh taic-airgid dhan iarrtas?
 - Ma tha:
 - Dè an t-sùim airgid a thathar a' moladh?
 - A bheil cumhaichean no prìomh chomharran coileanaidh (PCCan) ri mholadh airson an aonta
 - Mura h-eil, carson nach eil an t-iarrtas freagarrach?

Thèid na molaidhean seo, is sùim chuibheasach sgòran gach buill fa-leth, a chur dhan Sgioba Stiùiridh. Chan fheum na molaidhean a bhith stèidhichte a-mhàin air na sgòraichean cuibheasach, is dh'fhaodte gum biodh e iomchaidh moladh gun tèid gabhail ri iarrtas/iarrtas a dhiùltadh stèidhichte air adhbharan iomchaidh eile.

After the panel members have assessed each application, they will meet to reach an agreement on:

- Is support recommended for the application?
 - If so:
 - What sum is being recommended?
 - Are there any conditions or key performance indicators (KPIs) to be recommended for the agreement?
 - If not, why is the application not suitable?

These recommendations, along with the average scores of panel members, will be put to the Senior Management Team. The recommendations do not need to solely be based on the average scores, as it may be appropriate to recommend approval/rejection of an application based on other relevant factors.

Airson gach iarrais a tha am pannal-measaidh a' moladh dhan Sgioba Stiùiridh, faodaidh iad moladh gum bithear a' tabhann sùim taic-airgid a tha nas lugha na an t-sùim a chaidh iarraidh chun na h-ìre a tha am pannal den bheachd gum bi an t-sùim:

- 1) **A' toirt seachad luach an airgid do Bhòrd na Gàidhlig**
- 2) **Fhathast a' leigeil leis a' phròiseact tachairt (fiù ach pàirt dheth)**

For each application that the assessment panel recommends to the Senior Management Team, they may recommend a funding offer that is lower than the requested sum to the extent that the panel believes the amount provided:

- 1) Delivers value for money for Bòrd na Gàidhlig
- 2) Will still allow the project to continue (even if in part)

Ma tha barrachd taic-airgid air a mholadh dha pròiseactan na tha comasach a thaobh buidseat, bu chòir na molaidhean dhan Sgioba Stiùiridh a bhith air an dèanamh a-rèir sgòr iomlan a' phannail ach cuideachd gu bheil pròiseactan freagarrach air am maoineachadh ann an diofar sgìrean den dùthaich (m.e. dearbhadh gu bheil farsaingeachd de phròiseactan ann a-rèir cruinn-eòlas, cuspair). Faodar sgòr iomlan a sheachnadh ma tha adhbharan a tha am pannal measadh nas cudromaiche na seo (m.e. iarraitas le sgòr nas ìsle a tha cur taic ri choimhearsnachd nach bhiodh faighinn taic as a h-aonais, no iarraitas a' faighinn sgòr nas àirde ach nas freagarraiche airson sgeama eile no nach eil ceadaichte ann an dòigh theicnigeach).

If more funding is recommended for projects than budget will allow, the recommendations to the Senior Management Team should be made on the basis of the panel's total score for projects and any other relevant factors (e.g. ensuring a proportionate range of projects geographically, by subject). An application's average score may also be disregarded if there are factors that the panel believe outweigh this (e.g. an application receiving a lower score that supports a given community that would be without support otherwise or an application receiving a higher score but being more suitable for another scheme or ineligible in a technical way).

Co-dhùnidhean Sgioba Stiùiridh / Senior Management Team decision

Bidh Sgioba Stiùiridh Bhòrd na Gàidhlig a' tighinn gu co-dhùnadh air na h-iarritasan uile, a thaobh a bheilear a' toirt seachad taic-airgid no nach eil, agus ma tha an t-iarraitas soirbheachail dè an t-sùim a bhithear a thabhann is cumhaichean no PCCan ri chur san aonta.

Faodaidh an Sgioba Stiùiridh dol an-aghaidh molaidhean a' phannail gu tur no ann am pàirt, is chan eil e riatanach a bhith leantainn prìomhachas air na h-iarritasan air a chur an cèill leis a' phannal.

Dh'fhaodadh gun iarr an Sgioba Stiùiridh tuilleadh fiosrachaidh airson co-dhùnadh a dhèanamh, no dh'fhaodadh gun aontaich iad ri iarraitas "ann am prionnsapal", far am bi rudeigin ri choileanadh mus tèid taic aontachadh dhan a' phròiseact.

Bòrd na Gàidhlig's Senior Management Team will make the final decision on all applications, whether to award funding, what sum to award, and any conditions or KPIs for successful applications.

These decisions may disagree with recommendations of the panel, either in full or in part, without being required to follow the priority of applications set out by the panel.

The Senior Management Team may request further information to reach a decision, or may agree an application "in principle", whereby a condition must be fulfilled before support is agreed for the project.
