General guidance

Ma fhuair sibh taic tron sgeama ann an 2025/26, gheibh sibh lorg air foirm-iarrtais air a thòiseachadh dhuibh ann am Fluxx fon earrann "Iarrtasan / Applications" air taobh clì den sgrìon. Bidh agaibh fhathast ri chuid de cheistean a fhreagairt is fios as ùr a thoirt seachad, is bidh agaibh ri dhearbhadh gu bheil am fiosrachadh a bha ann fhathast fìor.

If you received support from the scheme in 2025/26, you will find an application form started for you in Fluxx under the "Iarrtasan / Applications" section on the left-hand side. You will still need to answer some of the questions and provide new information, and you will also need to confirm whether the information set out is still accurate.

Ma tha e nas fhasa faodar puingeann peileir a chleachdadh gus geàrr-chunntas a dhèanamh air bhur freagairt, ach dèanaibh cinnteach gu bheil fiosrachadh gu leòr air innse.

There are word guidelines for most of the questions to help guide how much detail you need to provide. If it is easier to use bullet points to summarise your answer feel free to do so, but ensure that there is enough detail provided.

Playleader hours and wages

We want to know how many hours each playleader will be employed for and how much they will be paid for their work.

Remember that we require all playleaders to receive a [minimum of the real Living Wage of £13.45 per hour](#) and that our support should only be used towards Gaelic-speaking playleaders.

Cosgaisean iomlan na buidhne airson na bliadhna

Total costs for the year

Dè cosgais iomlan a' bhuidheann agaibh airson na bliadhna-sgoile, a' toirt a-steach cosgaisean agus taic neo-airgeadach uile. Bheir seo beachd dhuinn air meud a' bhuidheann agaibh.

This is the sum that you are requesting from Bòrd na Gàidhlig and what we will use to assess your application. Remember that there are limits on the amount of funding we can provide (up to £4,000 for groups running 1 session a week, £15,000 for those running more than 1 session and

(£20,000 for organisations running multiple groups) and we expect you to have income from fees or donations.

Mar as trice, mar as ìsle an àireamh sa cheud de na cosgaisean iomlan a dh'iarraas sibh is ann as fheàrr a bhios an iarrtas agaibh sgòradh a thaobh luach an airgid.

Typically, the lower the percentage of total costs that you request from us the better your application will score in terms of value for money.

Teachd-a-steach/cosgaisean

Income/expenditure

An seo tha sinn airson barrachd fhaighinn a-mach mu na diofar rudan air a bheil dùil agaibh airgead a chosg, agus cò às a thig maoineachadh. Here we want to know more about the different items you are expecting to spend money on, and where funding will come from. We understand that these can change over time, but if you can be as specific as you can that will assist us in assessing the application.

In-kind support is allowed, and if there is something that is being contributed as in-kind (such as volunteer time) we'd ask you to include the monetary value of this in both the income and expenditure columns so that they match up.

Tha e cudromach gum bi an caiteachas agus an teachd-a-steach iomlan a tha san amharc ionann, leis nach urrainn dhuinn barrachd maoineachaidh a thoirt seachad na thèid iarraidh agus ma tha buidheann a' coimhead mar nach biodh teachd-a-steach gu leòr aige chan urrainn dhuinn taic a thoirt dha nas motha.

It's important that the planned total expenditure and planned total income are the same, as we can't provide more funding than is required and if a group looks as though it will not have enough income we can't support it either.

Ma tha dad ann a bu mhaith leibh innse dhuinn no mineachadh a bharrachd mun bhuidseat nach deigheadh sa chlàr leigibh fios dhuinn an seo.

As part of regulations relating to Subsidy Control that we have to follow, we need to ask if you have received less than £315,000 in public funding since 1 April 2024.

Tha sinn an dùil nach bi seo a' bualadh air a' mhòr chuid de bhuidhnean, mar sin taghadh Tha no Chan eil a-rèir am maoineachadh a fhuair sibh san ùine sin.

We expect that this will not apply to most groups, so simply choose Yes or No depending on your organisation's funding in that period.
